RESOLUTION NO. 2023-358

A RESOLUTION OF THE CITY COMMISSION DIRECTING THE CITY CLERK TO SCHEDULE A JOINT MEETING BETWEEN THE CITY'S ECONOMIC DEVELOPMENT BOARD AND CULTURAL DEVELOPMENT BOARD TO DISCUSS 2024-2025 CULTURAL ARTS AND ECONOMIC DEVELOPMENT PLANS AND THE 2026-2029 STRATEGIC PLAN AS WELL AS OTHER OPPORTUNITIES FOR PROMOTING THE CITY AS A CULTURAL DESTINATION.

WHEREAS, in November of 2023 the City Commission adopted a resolution directing the City Manager to include a focus area or goal related to cultural arts in the 2026-2029 Coral Gables Strategic Plan; and

WHEREAS, in furtherance of that direction the City Commission wishes to direct that a joint meeting be held between the City's Economic Development Board and Cultural Development Board prior to undergoing the process of drafting the 2026-2029 Coral Gables Strategic Plan in order to discuss the plan and the best way to address the goal of promoting the City as a cultural destination for South Florida residents and tourists now and within the strategic plan;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.



That the City Commission directs the City Clerk to schedule a joint meeting of the City's Economic Development Board and Cultural Development Board in the first quarter of 2024 prior to the drafting of the 2024-2025 budget and the City's undertaking of drafting the 2026-2029 Coral Gables Strategic Plan in order to address strategies for promoting the City as a cultural destination for South Florida residents and tourists.




