D. PEDRIDO ARTE GALLERY (UPDATE)

- Ribbon cutting event for Pedrido Arte Gallery was a successful event with a generous guest turnout. Pedrido made good use of their space, offering a stunning and thoughtfully curated environment that impressed all who attended.
- This pop up is for six months as dictated by their License Agreement with a term beginning August 15, 2025 thru February 14, 2026; with a renewal option for another six months.

E. RENT REPORT

- Rent report was prepared on August 11 identifying several tenants who have not made their payment.
- City Manager met with Francesco's to discuss past month's due. Although they submitted a payment for July, the check was returned due to insufficient funds.
- Currently the restaurant has decreased staff to continue to be profitable.
- All other businesses who were owing money are up to date with payments.
- Late fees are being charged for those who are late in payments.

F. OPEN DISCUSSION

- Cinema has submitted permits for their expansion plans. First round of plans has been reviewed.
- City Manager has requested current bank statements and attestation from their board to ensure that the amount of funds are appropriated.
- Graziano's Market has renewed their Lease Agreement and is currently being internally executed. They have completed several capital improvements and are currently working on completing remaining items.
