## **RESOLUTION NO. 2025-362**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE AND EXECUTION OF THE FISCAL YEAR 2025-2026 EMERGENCY MEDICAL SERVICES (EMS) COUNTY **GRANT** #C1013 LETTER OF UNDERSTANDING AGREEMENT FROM THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS AND THE STATE OF FLORIDA DEPARTMENT OF HEALTH, AND AUTHORIZING AMENDMENT TO THE FISCAL YEAR 2025-2026 ANNUAL BUDGET TO RECOGNIZE THE \$2,961.47 GRANT AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO COVER THE GRANT EXPENDITURES.

**WHEREAS**, the Florida Department of Health is authorized by Chapter 401, Part II, Florida Statutes to provide grants to Boards of County Commissioners for the purpose of improving and expanding pre-hospital emergency medical services; and

- **WHEREAS,** Miami-Dade County grants are awarded only to Boards of County Commissioners, but may subsequently be distributed to municipalities and other agencies or organizations involved in the provision of EMS pre-hospital care; and
- **WHEREAS,** Miami-Dade County is responsible for the application and distribution process of the State EMS County Grant; and
- **WHEREAS**, the distribution of grant funds to each participating department is based on the percentage of combined total EMS calls for the calendar year prior to the new grant's fiscal year; and
- **WHEREAS**, the application for the EMS County Grant #C2443 for Fiscal Year 2025-2026 was approved by the Miami-Dade County Board of County Commissioners and the Florida Department of Health-Bureau of EMS; and
- **WHEREAS**, the grant in the amount of \$2,961.47 has been approved for the City of Coral Gables' 2025-2026 work plan projects; and
- **WHEREAS,** in order to qualify for the grant, the City of Coral Gables must submit an approved Letter of Understanding/ Agreement which provides the basis for the disbursement and reporting responsibilities; and
- **WHEREAS,** an amendment to the Fiscal Year 2025-2026 Annual Budget is required to recognize the \$2,961.47 grant as revenue and to appropriate such funds to cover the grant expenditures;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby authorize the City to execute and submit a Letter of Understanding / Agreement to Miami-Dade County Fire Rescue Department as required for disbursement of payment of the new grant funds in the amount of \$2,961.47.

**SECTION 3.** That the City Commission hereby authorizes an amendment to the Fiscal Year 2025-2026 Annual Budget to recognize the \$2,961.47 grant as revenue and to appropriate such funds to cover the grant expenditures.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
