This 13.5-mile-long corridor will run from MiamiCentral station in Downtown Miami to the City of Aventura along the existing Florida East Coast (FEC) railway line. As part of this project, five new commuter rail stations and their associated park and ride sites are planned along the FEC Railway. Also, a train vehicle maintenance facility is planned at an

existing rail yard, located at 9400 NW 37th Avenue in Miami.
