Assistant Parks Recreation Director Vester stated she would like to take this moment as this is a very important message as we get ready to start our summer, further stating we can absolutely prevent drownings and that's what we try to do in many different capacities in the City and at Venetian Pool, and residents and guests, should keep that message, take that message home and do what one needs to do as due diligence to protect ones surrounding homes, pools and water areas. Assistant Parks Recreation Director Vester stated we're in South Florida we have pool front properties we have ocean front properties, we need to make sure our children our safe, and as 2 feet of water is enough water for a child to drown in, so we take every preventive measure. Assistant Parks Recreation Director Vester stated we have our Venetian Aquatic Club, which we are very fortunate to have over 150 volunteers to do swim lessons at the Venetian Pool. Assistant Parks Recreation Director Vester stated we also have our life safety staff, our lifeguards, as part of this proclamation we have included our Platinum Award, through Jeff Ellis and Associates, our risk provider we get certified and licensed through for our lifeguard system and we basically train our lifeguards. Assistant Parks Recreation Director Vester stated we are not here to just respond to a medical emergency, we are here to prevent a medical emergency and we take that very seriously, so seriously in fact we are rated among the top 10 percent Internationally to receive this award by Jeff Ellis and Associates. Assistant Parks Recreation Director recognized Aquatics Supervisor Jose Villar, Assistant Aquatics Supervisors Sarah Espino and Victoria Gonzalez and our lifeguards with a special designation made for Michael Machado, who is here today and who started with us 12 to 14 years ago and is a firefighter who still donates his part-time hours here at the City to make sure he contributes his knowledge as a firefighter with our lifeguards. Interim Economic Development Director Roberts welcomed everyone to the Coral Gables "Economic Development Week" Ceremony. Interim Director Roberts introduced his dedicated Economic Development Team, stating here with him today are Francesca Valdez, Business Development Coordinator, Lettie Perez, International Business Development Coordinator and Mariana Price our Administrative Assistant, who organized today's event. Interim Director Roberts stated he would also like to recognize and thank the members of the Economic Development Board who guide us in our activities and initiatives as follows: Carolina Reindero, Stuart McGregor and Olga Ramudo. Interim Director Roberts stated we are focused on not only retaining our amazing corporate clients, but bringing new ones into our City for that we depend on the help of our Trade Offices further thanking Trade Commissioners who have joined us this morning: Juan Camillo Berea, Executive Director for Pro-Columbia, the U.S. Business Office. Interim Director Roberts stated we have a short program for you and we want to be sure to start the Commission Meeting on time, so he will turn it over to our next speaker who we consider to be our Economic Development expert, City Manager Cathy Swanson-Rivenbark.

City Manager Swanson-Rivenbark stated Coral Gables is such a strong City, not only because of the desirable residential areas, but the role of the corporate, visitor, industrial, educational and medical play in making Coral Gables such a very special place; further stating we know that happened in our proud announcement of our "Triple-Triple". City Manager Swanson-Rivenbark stated we just got reaffirmed as a Triple A Bond Rated City by Fitch, Moody's, and Standard and Poor's, and it's because of the role of Economic Development, it's because of the strong financial practices, it's also because of the real estate prediction of health. City Manager Swanson-Rivenbark stated they were evaluating us on the thirty year horizon for the Public Safety Building, but when those 3 agencies looked at Coral Gables ability to pay, Coral Gables ability to lead and Coral Gables ability to thrive, they looked at a lot of different criteria, they concluded yes we are still a "Triple A", so thank you business community, cultural community, partners and thank you Coral Gables for

making that happen.

Mayor Valdez-Fauli stated that there was something our City Manager did not mention about the “Triple-Triple” Bond Rating, that is the great leadership in the City of Coral Gables, he is not talking about elective leadership, he is referring to the City Manager, her staff and everyone in Coral Gables, further thanking the City Manager and stating she is doing a great great job. Mayor Valdez-Fauli thanked everyone for being here today, stating you are the most important part of our economic life and we wish to recognize you and he would like to call his fellow Commissioners up to the dais to participate in this ceremony. Mayor Valdez-Fauli read the Proclamation into the record recognizing the importance of Economic Development to our City and presented the Proclamation to Interim Director Roberts.

[Note for the Record: Following Mayor Valdes-Fauli's reading of the title to Agenda Item 14 (i.e. Presentation of a Proclamation declaring May 8, 2018 as "Travel and Tourism Day" in Coral Gables, with William D. Talbert, President and CEO of the Greater Miami Convention and Visitors Bureau, to present an update on the state of the travel and tourism industry), Mayor Valdes-Fauli stated he has the privilege of calling on William Talbert.

City Manager Swanson-Rivenbark stated before Mr. Talbert begins, she just wanted to say how grateful we are for the relationship we have with the Convention and Visitor's Bureau, not only do they promote regionally, but they also celebrate the experience of Coral Gables. City Manager Swanson-Rivenbark stated they have been helping us with our Umbrella Project on Giralda and the Venetian Post project and with our new Venue Guide, so when people want a small special place for a wedding, or a conference they think of Coral Gables. City Manager Swanson-Rivenbark stated we look forward to them representing Coral Gables as a location.

President and CEO Talbert humorously thanked the City Manager Swanson-Rivenbark for presenting their report, adding we are going to sit down now, as there is not much to add to that. Mr. Talbert acknowledged Gene Prescott of the Biltmore Hotel, who is the Chairman Emeritus of the Bureau, and asked the rest of his team to stand up and be recognized. Mr. Talbert noted that "Miami Romance", the area's wedding show case, which is held in Coral Gables at the Biltmore every year and was held on February 25th and it is Miami Museum Month, and there are 2 fine museums located in Coral Gables, the Coral Gables Museum and the Lowe Museum at the University of Miami. Mr. Talbert stated that just a few days ago the World Strategic Forum was held here, which is like Davos (World Economic Forum), was

held at the Biltmore; further stating we had heads of state and he is looking forward to this Davos like forum continuing at the Biltmore for years to come. Mr. Talbert stated that last year was a record year for tourism in Coral Gables, as in the first quarter Coral Gables and Miami, we are number 1 in RevPAR in the United States in that we are number 1 in hotel occupancy and occupancy rate, and it's number 1 by a lot and last year we were number 2. Mr. Talbert stated this year things are going so well, because of the partnerships, which the Manager mentioned, and we don't take those for granted; for as well as we are doing, we are always keeping our eye out for the competition. Mr. Talbert stated we are the only location that has more than 50 percent International visitors, there is not a place in the country that wouldn't want to take that away from us and were not going to let that happen. Mr. Talbert stated we will continue to be number 1, because of the partnerships, and the marketing campaign of your Greater Miami Convention and Visitor's Bureau.

Mr. Gene Prescott of the Biltmore stated we see a lot of competition as you know; we compete in Coral Gables with Miami Beach, we as a destination with Orlando and the Islands, Las Vegas and some of other spots in the Caribbean. Mr. Gene Prescott stated the key is the International market, where we get over 50 percent; Brazil 2-3 years ago was our largest foreign market, and because of their economic downturn, we had to find other markets, and now Columbia is the largest in terms of economic impact for our destination. Mr. Gene Prescott stated as individual hoteliers and the bureau, we have a lot of partners, such as the City of Coral Gables and the other municipalities and the County and Visit Florida. Mr. Gene Prescott further stated, we have a joint effort and we have a good product here as a destination; you have to invest, as you know, in our facilities and the product that we are offering to the public, building is going on in other destinations, not the least at the Beach, and Orlando, where they're building a lots of rooms. Mr. Gene Prescott stated that we in the industry appreciate the City's active involvement, and he personally says that on behalf of the Biltmore.

Mr. Talbert stated were going to celebrate "National Travel and Tourism Month", but on behalf of the bureau, your bureau, we view every day is "Travel and Tourism Day" in Coral Gables, we are working every day. Mr. Talbert stated we are a big event town, in a little more than 600 days we are going to have our 11th Super Bowl, no community has had 11 Super Bowls, a year later we are going to have the College Football Championship and we have put together a bid for World Cup 2026, and we are confident we are going to be on that list. Mr. Talbert thanked the City Commission for their support.

Mayor Valdez-Fauli stated 2 months ago we had the “World Happiness Forum”, despite its name, was a fantastic meeting of Ministers of Economics from Japan and Minister of Social Welfare from Europe and professors from all over the world on the subject of what constitutes happiness; we had the event at the Venetian Pool and at UM and some of them may have stayed at the Biltmore, and it was extremely successful event that really highlighted Coral Gables.

Mr. Talbert stated they will be back next year.

Mayor Valdez-Fauli stated that he was meeting with County Clerk Harvey Rugin and he said that Miami-Dade County is unique in the United States in that 53 percent of our residents were born outside the United States. Mayor Valdez-Fauli stated we are very much a multi-national community and we’re very proud of it and it makes us very attractive place to visit.

Mr. Prescott read a Proclamation to the Miami-Dade County Convention and Visitor’s Bureau to the Mayor, Commissioners and City Manager for their leadership and support of our travel and tourism success in commemoration of National Travel and Tourism Month for May, 2018.

So we should have that update, I'm going to put that on the Commission Agenda for the 22nd. Everybody was concerned, but the Mayor has brought it up the last two meetings.

Mayor Valdes-Fauli: Thank you.

City Attorney Ramos: Mr. Mayor, I'd like to just briefly mention on the recent win that the City had on the case of Cascar versus City of Coral Gables. This lawsuit was filed in 2013. It attacked our historic preservation ordinance and a subsequent denial of the demolition permit based on the historic designation; and it came to the tune of a \$7 million dollar potential liability to the City. So it's a huge win. It certainly can be appealed, we are hopeful that it will not be. Not only financially is it a win for the City, but also to our historic preservation ordinance.
