RESOLUTION NO. 2024-67

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE AND EXECUTION OF GRANT FUNDS IN THE AMOUNT OF \$6,796 ALLOCATED TO THE CORAL GABLES POLICE DEPARTMENT FROM THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2023-2024 ANNUAL BUDGET TO RECOGNIZE THE \$6,796 GRANT FUNDS AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO COVER THE GRANT EXPENDITURES.

WHEREAS, the Coral Gables Police Department is the established local law enforcement agency for the provision of law enforcement services within the jurisdictional boundaries of the City of Coral Gables; and

WHEREAS, the Coral Gables Police Department submitted an application to the State of Florida Department of Law Enforcement under the Edward Byrne Memorial Justice Assistance Grant Program; and

WHEREAS, the Coral Gables Police Department proposed the grant amount of \$6,796 be used to purchase equipment that will enhance community policing to foster trust; and

WHEREAS, the State of Florida Department of Law Enforcement notified the Coral Gables Police Department that its grant application was successfully reviewed and approved via Award Number C-R7154 on March 13, 2024; and

WHEREAS, the Coral Gables Chief of Police requests acceptance of the grant and execution of the grant funds in the amount of \$6,796; and

WHEREAS, an amendment to the Fiscal Year 2023-2024 Annual Budget is required to recognize the \$6,796 grant as revenue and to appropriate such funds to cover the grant expenditures;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission hereby authorizes the acceptance and execution of grant funds in the amount of \$6,796 allocated to the Coral Gables Police Department from the Edward Byrne Memorial Justice Assistance Grant Program.

SECTION 3. That the City Commission hereby authorizes an amendment to the Fiscal Year 2023- 2024 Annual Budget to recognize the \$6,796 grant funds as revenue and to appropriate such funds to cover the cost of the grant expenditures.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.




