**RESOLUTION NO. 2020-67**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING A CHANGE ORDER TO THE ELEVATOR, ESCALATOR AND MOVING WALKS WITH RELATED EQUIPMENT, SERVICES, ACCESSORIES AND SUPPLIES CONTRACT 100516-TKE WITH THYSSENKRUPP ELEVATOR CORPORATION, PURSUANT TO SECTION 2-764(B), APPROVAL OF CHANGE ORDERS IN THE ESTIMATED AMOUNT OF \$337,061 FOR REPAIRS TO THE GARAGE 6 ELEVATORS.

**WHEREAS**, the City has elevators located throughout the City that require regular routine maintenance which may include unexpected service repairs; and

**WHEREAS**, the maintenance needs must be outsourced to professionals that can safely and efficiently address those needs; and

**WHEREAS**, the City entered into a piggyback agreement pursuant to Procurement Code Section 2-945 with ThyssenKrupp Elevator Corporation to provide elevator maintenance and services on May 24, 2018; and

**WHEREAS**, the service contract provides for a comprehensive solution to elevator, escalator, and moving walk needs while providing installation, maintenance, and repair services; and

**WHEREAS**, an immediate need has risen to address the two existing elevators at Garage 6 with repairs that consist of refurbishment, new mechanical equipment, and cab renovations;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

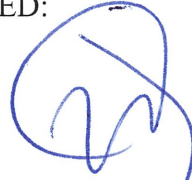

**SECTION 2.** That the City Commission authorizes an increase in the award amount for contract number 100516-TKE in an initial amount of \$337,061 and approves the additional spending authority through the remaining term of the agreement in amount not to exceed the available budget.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.

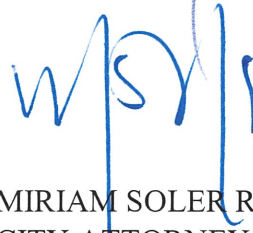
