RESOLUTION NO. 2009-264

A RESOLUTION AUTHORIZING THE EXTENSION OF A CONTRACT WITH GYM KIDZ, INC. PURSUANT TO SECTION 2-834 (D) OF THE PROCUREMENT CODE ON A MONTH TO MONTH ON AN AS NEEDED BASIS UNTIL SUCH TIME AS A NEW CONTRACT IS EXECUTED FOR THE PROVISION OF GYMNASTICS PROFESSIONAL SERVICES, OR REBID IF NECESSARY.

WHEREAS, on February 9, 2004 the City Commission approved a contract with Gym Kidz, Inc. for the provision of gymnastic professional services; and

WHEREAS, the contract provided for an initial two (2) year term with an option to renew for three (3) additional one (1) year terms with the last term expiring June 1, 2009; and

WHEREAS, the contract was extended for one hundred twenty (120) days to September 28, 2009 to provide time to re-solicit and execute a new contract; and

WHEREAS, the Procurement Division of Finance formally solicited proposals for gymnastic professional services on June 26, 2009 under RFP 2009.06.23, with proposals submitted by July 30, 2009; and

WHEREAS, under Section 2-834(d) of the Procurement Code this Gymnastics Professional Services contract with Gym Kidz, Inc. should be extended on a month-to-month as needed basis from the expiration of current contract extension (September 28, 2009) until such time as a new contract is executed, or rebid if necessary; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption herein.

SECTION 2. That the City Commission does hereby accept the recommendation of the Chief Procurement Officer pursuant to Section 2-834(d) to extend the gymnastics professional services contract with Gym Kidz, Inc. on a month to month as needed basis from the expiration of the current contract extension (September 28, 2009) until such time as a new contract is executed, or rebid if necessary.

SECTION 3. That this Resolution shall become effective upon the date of its adoption herein.
