RESOLUTION NO. 2024-197

A RESOLUTION OF THE CITY COMMISSION DIRECTING CITY STAFF TO EXPLORE ADDITIONAL NOTICE OPTIONS WITH THE CITY'S ARTS ADVISORY PANEL AND CULTURAL DEVELOPMENT BOARD WHEN THE CITY IS ACQUIRING AND INSTALLING NEW WORKS OF ART UTILIZING THE CITY'S ART FUND.

WHEREAS, the City maintains a robust art in public places program which address the important goal of commissioning, acquiring, and exhibiting new public artworks in Coral Gables; and

WHEREAS, the City Commission has consistently expressed interest in building the City's permanent public art collection with artworks by prominent artists representing a diversity of backgrounds and disciplines; and

WHEREAS, when utilizing the art acquisition fund to obtain and install new art works the City Commission wishes to explore additional avenues for notice for those interested residents and stakeholders; and

WHEREAS, given the complex process for acquiring works of art and the valued expertise of the City's Arts Advisory Panel and Cultural Development Board, the City Commission wishes for staff to discuss additional notice provisions with the relevant boards to determine how best to inform the public regarding these acquisitions;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:


SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the Coral Gables City Commission hereby directs City staff to explore additional notice options with the City's Arts Advisory Panel and Cultural Development Board for instances when the City is acquiring and installing new works of art utilizing the City's art fund.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
