RESOLUTION

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD Y&T PLUMBING SERVICES CORP., AND DOUGLAS ORR PLUMBING, INC., (SECONDARY) AS THE TWO MOST RESPONSIVE AND RESPONSIBLE BIDDERS FOR PLUMBING SERVICES PURSUANT TO INVITATION FOR BID (IFB) 2024-030 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on July 16, 2024, the Procurement Division of Finance formally advertised, issued, and distributed Plumbing Services, IFB 2024-030. Sixty-three (63) prospective bidders were notified through INFOR, the City's web-based e-Procurement system; and

WHEREAS, on August 30, 2024, two (2) bids were received in response to the IFB: Douglas ORR Plumbing, Inc., and Y&T Plumbing Services Corp; and

WHEREAS, the responses were reviewed by the Procurement Division in order to determine responsiveness to the requirements of the IFB; and

WHEREAS, the Public Works Division concurs with the Chief Procurement Officer's recommendation to award Y&T Plumbing Services Corp., (Primary), and Douglas ORR Plumbing, Inc., (Secondary) as the two most responsive and responsible bidders; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on contract awards.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager to award Y&T Plumbing Services Corp., (Primary), and Douglas ORR Services, Inc., (Secondary) as the two most responsive and responsible bidders for Plumbing Services for a three (3) year term contract with option to renew for two (2) additional one (1) year periods, in an amount not to exceed the available budget pursuant to Section 2-763 of the Procurement Code entitled "Contract Award" and Invitation for Bids (IFB) 2024-011.

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
