**RESOLUTION NO. 2025-\_\_**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION TO AUTHORIZE THE AWARD OF A PURCHASE AND SERVICE AGREEMENT WITH EARTH POWER SOLUTIONS, INC IN AN ESTIMATED AMOUNT OF \$104,776 AS A “SOLE SOURCE PROCUREMENT,” PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE

**WHEREAS**, the Police Department has determined a need exists to maintain the Eaton backup power equipment for the City’s primary and secondary 911 dispatch centers, network data center, and replace three end-of-life UPS units at public safety radio sites, and

**WHEREAS**, Eaton Corporation is the creator, and manufacturer of the Eaton Uninterpretable Power Supply (UPS); and

**WHEREAS**, Earth Power Solutions, Inc. is an authorized representative for Eaton; and

**WHEREAS**, the cost to acquire replacement equipment and maintenance services will be in an estimated amount of \$104,776; and

**WHEREAS**, Section 2-689 of the Procurement Code, entitled “Sole Source Procurement” authorizes an award without competitive bids when there is only one source available to fulfill the needs of the City; and

**WHEREAS**, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on awards;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation and authorizes the City Manager to enter into a purchase and service agreement with Earth Power Solutions, Inc., in an amount not to exceed the available budget and to cover on-going maintenance needs pursuant to Section 2-689 of the City’s Procurement Code.

**SECTION 3.** That this Resolution shall become effective upon the date of its adoption herein.
