RESOLUTION NO. 2024-134

A RESOLUTION OF THE CITY COMMISSION NAMING THE PRIMARY THOROUGHFARE OF THE GABLES FAMILY LITERACY FESTIVAL LOCATED PARALLEL TO UNIVERSITY DRIVE WITHIN THE WAR MEMORIAL YOUTH CENTER, IN HONOR OF FORMER CORAL GABLES COMMISSIONER, JEANNETT SLESNICK, WITH THE NAME “COMMISSIONER JEANNETT SLESNICK LITERACY ROW.”

WHEREAS, Jeannett Slesnick served as a City Commissioner, held various organizational leadership roles, was a successful business owner, and a pillar of the Coral Gables Community ; and

WHEREAS, the City Commission wants to honor her service and devotion to the City of Coral Gables; and

WHEREAS, the annual Gables Family Literacy Festival, held in the parking area of the War Memorial Youth Center parallel to University Drive, enriches the community in its celebration of reading and the literary arts; and

WHEREAS, the City Commission requests that the main thoroughfare of the Gables Family Literacy Festival, that area within the War Memorial Youth Center parallel to University Drive, be named “Commissioner Jeannett Slesnick Literacy Row” in honor of Jeannett Slesnick’s dedication to enriching our community;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:


SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the main thoroughfare of the Gables Family Literacy Festival, that area within the War Memorial Youth Center parallel to University Drive, be named “Commissioner Jeannett Slesnick Literacy Row.”

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


