RESOLUTION NO. 2023-130

A RESOLUTION OF THE CITY COMMISSION DIRECTING THE CITY MANAGER TO IMPLEMENT A PILOT PROGRAM PLACING AUTOMATED EXTERNAL DEFIBRILLATORS (AED) IN ADDITIONAL CITY PARKS, AND A PILOT PROGRAM PLACING SMART EMERGENCY STATIONS IN CERTAIN CITY PARKS.

WHEREAS, currently the City of Coral Gables Fire Department manages the City's Public Access Defibrillation program for the City; and

WHEREAS, the City currently has 44 AED located in City facilities, including parks, an additional 150 AED in Coral Gables Police vehicles, 10 AED in Fire Department staff vehicles, and 11 AED in Neighborhood Safety Aide vehicles; and

WHEREAS, the City Commission is interested in enhancing the availability of AED, as well as increased security measures in those City parks that are not permanently staffed by City personnel; and

WHEREAS, the City Commission believes that two pilot programs, one adding separated AED and Code Blue Smart Emergency Stations at Rotary Park and Salvadore Park and, another adding Code Blue Smart Emergency Stations or similar devices to some other City parks would be in the best interest of the City and allow the City management to review the success of those pilot projects; and

WHEREAS, the City Commission directs that the City Manager determine the size, scope, duration, and location of those two pilot programs in consultation with the City's Police Chief, Fire Chief, IT, and Community Recreation staff, and add the pilot programs in the FY 23-24 budget, subject to available funding;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission directs the City Manager to develop, along with the City's Police Chief, Fire Chief, IT, and Community Recreation staff, two pilot programs, one adding separated AED and Code Blue Smart Emergency Stations, or similar devices, at Rotary Park and Salvadore Park and, another adding Code Blue Smart Emergency Stations, or similar devices, to other City parks. The City Manager should determine the size, scope, duration, and locations of those two pilot programs and add the pilot programs to the FY 23-24 budget for approval by the City Commission.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
