RESOLUTION NO. 2011-273

RESOLUTION EXTENDING THE TOWING SERVICES CONTRACT WITH DOWNTOWN TOWING COMPANY, PURSUANT TO SECTION 2-829 OF THE PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS" ON A MONTH TO MONTH BASIS FROM DECEMBER 1, 2011 FOR A PERIOD NOT TO EXCEED THREE (3) MONTHS TO PROVIDE ADDITIONAL TIME FOR A NEW TOWING CONTRACT TO BE EXECUTED.

WHEREAS, on July 15, 2008, the City Commission approved a two (2) year contract for towing services with Downtown Towing Company, which expired on December 1, 2010; and

WHEREAS, this contract provides for on-call twenty-four (24) hours, seven (7) days per week vehicle towing and storage services; and

WHEREAS, this contract was extended until June 1, 2011 to solicit proposals for a new contract; and

WHEREAS, on May 20, 2011, an untimely "Notice of Intent to Protest" was filed by another Towing Services RFP proposer under Section 2-950 of the Procurement Code entitled "Resolution of Protested Solicitations and Awards-Formal" and as a result contract extensions of four (4) months and two (2) months were given to provide time to review the issues raised by the other RFP proposer and to execute a new contract; and

WHEREAS, an additional three (3) month extension of the towing services contract is needed to examine additional information and documentation submitted in regard to Sunshine Towing, Inc., the firm ranked the most responsive and responsible as a result of the Towing Services RFP evaluation; and to resolve any potential protest and to execute a new towing services contract; and

WHEREAS, the Chief Procurement Officer recommends extending the towing services contract an additional three (3) months; and

WHEREAS, the towing services contract with Downtown Towing may be extended under Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications," on a month to month basis from December 1, 2011 for a period not to exceed three (3) months;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City of Coral Gables Commission hereby extends the towing services contract with Downtown Towing Company, pursuant to Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications" on a month to month basis from December 1, 2011 for a period not to exceed three (3) months to provide time for a new towing contract to be executed.

SECTION 3. That all Resolutions or parts of Resolutions inconsistent with, or in conflict herewith, shall be and are hereby repealed insofar as there is conflict or inconsistency.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
