RESOLUTION NO. 2023-344

A RESOLUTION OF THE CITY COMMISSION DIRECTING THE CITY MANAGER TO INCLUDE AN ITEM ON THE CITY COMMISSION AGENDA REGARDING CITY COMMISSION COMPENSATION AT A REGULAR CITY COMMISSION MEETING PRIOR TO THE PRESENTATION OF THE DRAFT BUDGET TO THE CITY COMMISSION.

WHEREAS, in accordance with those procedures set forth in state law, the City Charter, and City Code the City Manager prepares and submits to the Commission a budget estimate not later than three months before the end of each fiscal year; and

WHEREAS, following various workshops and public hearings the budget is adopted as an ordinance after two readings; and

WHEREAS, in order to increase transparency and allow additional public notice regarding any changes to the compensation of the City Commissioners, beyond the annual CPI increase set forth in Section 2-29 of the City Code, the City Commission wishes to direct the City Manager to include a discussion item regarding the compensation of the City Commission to be included in the forthcoming draft City budgets; and

WHEREAS, this discussion item shall be placed on the agenda of a regular City Commission meeting prior to the presentation of the draft budget to the City Commission;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.



That the City Commission hereby directs the City Manager to include an item on the City Commission agenda regarding the compensation of the City Commissioners, if the changes are beyond the annual CPI increase set forth in Section 2-29 of the City Code, at a regular City Commission meeting prior the presentation of the draft budget to the City Commission.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


