**RESOLUTION NO. 2008-**

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA, SUPPORTING LEGISLATION ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA IN CONNECTION WITH THE CO-DESIGNATION OF SOUTHWEST 37<sup>TH</sup> AVENUE FROM SOUTHWEST 8<sup>TH</sup> STREET TO SOUTHWEST 22<sup>ND</sup> STREET AS WILLIAM H. KERDYK, SR., AVENUE;

**WHEREAS**, William H. Kerdyk, Sr., tenure as city commissioner is the longest of any Coral Gables commissioner; and

**WHEREAS**, in 1967 at age 39, Kerdyk was elected to the City of Coral Gables Commission and for nearly three decades, he witnessed the growth of his beloved city as a commissioner; and

**WHEREAS**, over three decades as a city commissioner, Kerdyk sponsored many ordinances that preserved and improved the quality of life for the residents of this community; and

**WHEREAS**, Kerdyk was immersed in the community as a member of the Coral Gables Chamber of Commerce, the Rotary and Elks Clubs, the South Florida Planning Advisory Board and many others; and

**WHEREAS**, Kerdyk passed away on April 27, 2007; and

**WHEREAS**, on November 20, 2008, the Board of County Commissioners of Miami-Dade County, Florida proposed the co-designation of a county road located in County Commission Districts 6 and 7;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The City Commission urges the City of Miami to support Miami-Dade legislation co-designating Southwest 37<sup>th</sup> Avenue from Southwest 8<sup>th</sup> Street to Southwest 22<sup>nd</sup> Street as William H. Kerdyk, Sr., Avenue.

**SECTION 3.** The City Clerk shall provide executed copies of this resolution to the Mayor of Miami-Dade County.

**SECTION 4.** This resolution shall become effective upon the date of its passage and adoption herein.
