RESOLUTION NO. 2022-19

A RESOLUTION OF THE CITY COMMISSION CONFIRMING THE NOMINATION OF CHRISTOPHER CHALLENGER, WHO RAN UNOPPOSED TO THE CITY OF CORAL GABLES RETIREMENT BOARD, AT-LARGE PARTICIPATING REGULAR FULL-TIME EMPLOYEE REPRESENTATIVE SEAT AND JOSHUA NUNEZ, WHO RAN UNOPPOSED FOR THE POLICE OFFICER REPRESENTATIVE SEAT, BOTH FOR A TWO-YEAR TERM BEGINNING JANUARY 1, 2022 THROUGH DECEMBER 31, 2023.

WHEREAS, on Friday November 12, 2021, a Nominating Petition form was emailed to each department/division, within the City of Coral Gables to nominate a candidate for the At-Large Participating Regular Full-time Employee Representative seat and Police Officer Representative seat; and

WHEREAS, on Friday, December 3, 2021, 5:00 p.m., deadline for submittal of Nominating Petition forms for candidates to serve on the Coral Gables Retirement Board, Christopher Challenger ran unopposed for the At-Large Participating Regular Full-time Employee Representative seat, thereby declaring him the winner and Joshua Nunez ran unopposed for the Police Officer Representative seat declaring him the winner;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:


SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. That the City Commission does hereby confirm the nomination of Christopher Challenger as the At-Large Participating Regular Full Time Employee Representative, and nomination of Joshua Nunez as the Police Officer Representative members of the Coral Gables Retirement Board to serve a two-year term beginning January 1, 2022 through December 31, 2023.


SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
