12. Investment Issues were discussed.

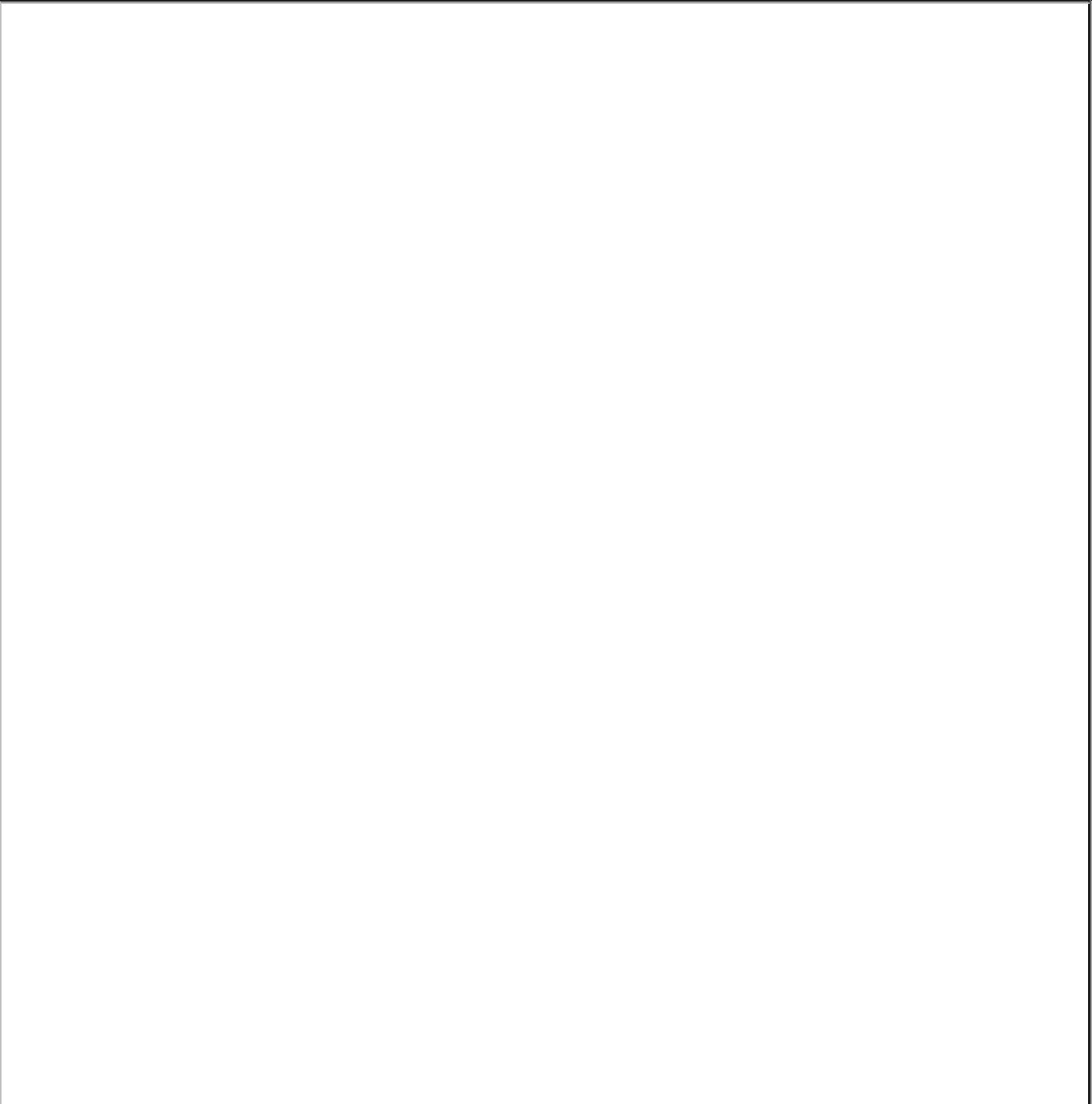
13. There was no Old Business to discuss.
