RESOLUTION NO. 2010-118

RESOLUTION AUTHORIZING THE ACCEPTANCE AND EXECUTION OF EMERGENCY MEDICAL SERVICES (EMS) COUNTY GRANT #C9013 LETTER OF UNDERSTANDING AND AGREEMENT IN THE AMOUNT OF FOUR THOUSAND SEVEN HUNDRED AND SIXTY DOLLARS (\$4,760.00) FROM THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS AND THE STATE OF FLORIDA DEPARTMENT OF HEALTH FOR FISCAL YEAR 2009-2010, TO FUND THE EXPANSION AND/OR IMPROVEMENTS OF PRE-HOSPITAL EMERGENCY MEDICAL SERVICES.

WHEREAS, the Florida Department of Health is authorized by Chapter 401, Part II, Florida Statutes to provide grants to Boards of County Commissioners for the purpose of improving and expanding pre-hospital emergency medical services; and

WHEREAS, Miami-Dade County grants are awarded only to Boards of County Commissioners, but may subsequently be distributed to municipalities and other agencies or organizations involved in the provision of EMS pre-hospital care; and

WHEREAS, Miami-Dade County is responsible for the application and distribution process of the State EMS County Grant; and

WHEREAS, the distribution of grant funds to each participating department is based on the percentage of combined total EMS calls for the calendar year prior to the new grant's fiscal year; and

WHEREAS, the application for the EMS County Grant #C9013 for Fiscal Year 2009-2010 was approved by the Miami-Dade County Board of County Commissioners and the Florida Department of Health-Bureau of EMS; and

WHEREAS, the grant in the amount of four thousand seven hundred and sixty dollars (\$4,760.00) has been approved for the City of Coral Gables' Fiscal Year 2009-2010 work plan projects; and

WHEREAS, in order to qualify for the grant, the City of Coral Gables must submit an approved Letter of Understanding/Agreement which provides the basis for the disbursement and reporting responsibilities;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby approve that the City may submit an approved Letter of Understanding/Agreement to Miami-Dade County Fire Rescue Department as required for disbursement of the new grant funds in the amount of four thousand seven hundred and sixty dollars (\$4,760.00).

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
