Mayor Lago introduced Agenda Item A-1 declaring April 29, 2022 as "Arbor Day" in Coral Gables. Commissioner Anderson stated that it was the Commission's pleasure to see more trees planted in the City and to fill-in all hot streets with flowering trees and welcomed Deena Bell-Llewellyn-Assistant Director, Public Works/Greenspace Management Division and Elizabeth Parnes, Board Member/Landscape Beautification Advisory Board, and then read the proclamation.

Deena Bell-Llewellyn-Assistant Director, Public Works/Greenspace Management Division stated that she and her staff think it is a great blessing to have a Mayor and Commissioners who honor trees and tree canopy landscaping, and that it was Earth Month, Landscape Architecture Month and the 200th birthday of Frederick Law Olmsted, the Father of Landscape Architecture. She then introduced Elizabeth Parnes, Board Member/Landscape Beautification Advisory Board and Joy Matthews. Ms. Parnes stated that she is the Landscape Beautification Advisory Board Chair, and their mission is to oversee the plans for the beautification of all green spaces within the city. Every year private homeowners and commercial property owners are recognized for their commitment and aesthetic beauty of their properties, what they do to enhance the City and listed the required criteria. Ms. Bell-Llewellyn then gave a PowerPoint presentation. Mayor Lago commended the homeowners and the teams that maintain exquisite, landscaped homes, and with the City Manager and City Commission they are going to beautify the City and replicate what these award winners are doing. He then showed pictures of his recent visit to New York, being impressed in seeing a clean city with beautifully installed flowers and how the city was trying to put their best foot forward. He stressed that Coral Gables should never lose their identity because that is what makes it special and if they do, people will leave, and that they are going to change the Downtown making it more beautiful and welcoming. He also commended the winners on the pride taken in beautifying their property and it is reflective of who they are as a community and listed the numerous projects that are going to taking place to beautify the Downtown and thanked them for elevating the quality of life in Coral Gables. Mayor Lago and City Commissioners then presented each winner with their plaque.

Ms. Bell-Llewellyn introduced Solanch Lopez/Assistant to the City Manager and Matt Anderson, Senior Sustainability Analyst regarding “Keep Coral Gables Beautiful”. Mayor Lago stated that he received a request from a resident inquiring about participating at the next clean-up. Ms. Lopez indicated that it would be at the end of May and that they are in the process of confirming the date and will get back to him. Continuing, the partnership with the Landscape Beautification Advisory Board awards through Deena, Economic Development, the Chamber, and the Business Improvement District (BID) they are also launching a “Keep Coral Gables Beautiful” Commercial Beautification Awards specifically for the businesses and in so doing the Landscape Board can continue focusing on the beautiful landscaping around residential homes and there is an award opportunity for the commercial district. The criteria follows more or less the ones stipulated by Deena and tweaked to the businesses with the nomination process beginning soon with the BID, Chamber, Code Enforcement, Economic Development nominating the businesses because they are the

ones who are in the commercial districts the most and she will return with additional information and is hopeful they will have the first awardee in July with the objective of bringing one business each commission meeting once they have the winners, allowing for them to have a special spotlight on them. Mayor Lago said he loves the idea, and it is a great opportunity to showcase what some of the businesses in the Downtown are doing. Case in point, the Fink Studio looks incredible and congratulated the entire city for accomplishing that and moving into the building and he is looking forward to seeing the nominees. Ms. Lopez thanked the Mayor. Vice Mayor Mena thanked them on the recycling done at City Hall during the weekend which was another success and a great experience to drive through it as a resident and to have that service. It ran smoothly, Police did a great job in keeping the line queued-up; it is a great system in utilizing both parking lots and residents love the events and congratulated them. Mr. Anderson said they received a lot of positive feedback, and it was their third largest event to date with 580 cars and 1150 people passing through the event in three hours. It is a team effort with Solanch, Public Works, Police, himself, and it takes a village to conduct such an event. Additionally, the residents and all the feedback they received was extremely positive and the number one question was when the next event will be. They are still awaiting the total amount of garbage received which should be available by mid-week and will put a story in e-News summarizing the event and thanked the City Commission for their continued support. It is a service that is set apart from other cities and have received numerous calls from other cities regarding this important service, and this is just another way of keeping the City beautiful. Mayor Lago thanked them all for their efforts. Commissioner Anderson chimed in stating that the other question she gets is, can they do more, can they do it more often? She thanked Solanch for the battery and prescription drop-off, that they are moving in a positive direction, and the Mayor concurred that it is a testament to her hard work.

Mayor Lago introduced Agenda Item A-3, a presentation of a proclamation declaring May 2-6, 2022 as "Teacher Appreciation Week" in Coral Gables. He then introduced Miami-Dade County School Board Member Mari Tere Rojas who represents the City with dignity and class, and recognized members of the School and Community Relations Committee (SCRC) who work diligently on behalf of the students in the schools to ensure that relationships are only getting better, Ariel Fernandez, Jennifer Sandol and Winne Chang. (phonetic) Ms. Rojas stated that it was a pleasure to be there representing the entire School Board, Perla Tabares, Board Chair, Dr. Steven Gallon, III, Vice Chair, her colleagues on the Board and she is the City's proud member representing District 6. Mayor Lago introduced Agenda Item A-4 regarding the presentation of a proclamation declaring May 5, 2022 as "Israeli Independence Day" in Coral Gables. He stated that the request for the proclamation was brought to his attention two months ago and felt it critically important that these moments are celebrated and while he is not Jewish, but Catholic, he feels that they are still brothers, and that especially today, we lack tolerance, the ability to have a civil disagreement and being able to come to some sort of core agreement, and sees this as an opportunity to celebrate an important day in history, especially in these difficult times of antisemitism, disrespect, wars that are raging, a level of disrespect at the national, sometimes at the state and local level, a moment taken to honor individuals in who represent the community as a whole, and there has been a deep struggle to honor Israel and believes in honoring Israel for their achievements across a major broad spectrum. He then read the proclamation. Rabbi Avrohom Stolik is the Director of Chabad of Downtown Coral Gables stated that they are appreciative of the Mayor and City Commission for being so supportive of the Jewish community and the State of Israel because it means a lot to them and thanked them. Consul General Maor Elbaz-Starinsky stated that he echoes the same sentiments because it would not have been so successful without the support of the United States of America and thanked the USA, the wonderful State of Florida, and the City of Coral Gables. Additionally, as Consul General he and the State of Israel are committed to partnering with all communities in the nation and continuing to create a better and brighter future for communities. Regarding tolerance, he stated that we don't see enough intolerance to intolerance, that we should be intolerant to intolerance, and all should fight the trend of antisemitism and racism together which is not only a problem of the Jews, but also a problem of this society and there is no better place to do that, than Southern Florida. He thanked the City Commission and said he was humbled and excited to be at the meeting and appreciates all that they are doing for the Jewish community.

Mayor Lago introduced Agenda Item A-5 regarding the presentation of a proclamation declaring May 2-5, 2022 as "National Small Business Week" in Coral Gables and Vice-Mayor Mena read the proclamation. Julian Perez, Economic Development Director thanked the Mayor and City Commission for the opportunity and it being an important day to celebrate. Continuing, he said that 98% of businesses in Coral Gables are small businesses with less than 50 people employed who are local contributors not only to their local regional, but also to the national economy. In looking at how well the business ecosystem has done in the last two years in comparison to other places, especially Miami-Dade County, they are No. 2 in the nation in generating new establishments, that's in Miami-Dade County. He continued by speaking of new businesses during the pandemic, jobs generated and considers it a tremendous achievement for all involved in this process. He mentioned The Alliance for Multi-Special Research or AMR Miami that has had a tremendous impact in working diligently to find a solution to the pandemic with Dr. Jeffrey Rosen, Founder of the Clinical Research of South Florida, now AMR. Mr. Perez then outlined the numerous contributions made by Dr. Rosen and his staff in the community. He then introduced Mark Trowbridge, President and CEO of the Coral Gables Chamber of Commerce who stated that he was honored to be there, and they too have contributed much with Small Businesses and other initiatives, working with the Small Business Administration (SBA) in putting programs together during Small Business Week - May 2-6th which is also Teacher Appreciation Week, so they are sharing the space with them which is a perfect alignment for those who are preparing our future workforce and consumers.
