AWARD NOMINATION

It is with great pleasure that I nominate Officer Robert Thomson for the distinguish Officer of the Month Award. Documented below is the incident that motivated me to generate this memo.

On January 6, 2020, at approximately 8:58 a.m., while on routine patrol, Officer Thomson was traveling eastbound on SW 8 Street when he was alerted via City of Coral Gables Automatic License Plate Reader System (ALPR) of a stolen black BMW bearing FL Tag QNFV93. Officer Thomson observed the vehicle traveling westbound at the 5100 Block of SW 8 Street. The vehicle then made a left turn onto Columbus Blvd. Officer Thomson followed the vehicle until the vehicle pulled into the driveway of 837 Columbus Blvd. where he ordered the driver, Lazaro Y. Hernandez, and two passengers, Yailen H. Fernandez and Francisco Carone out of the vehicle. Officer Thomson was able to identify them through verbal communication and Teletype. A record check on the vehicle revealed that on January 5, 2021, it was reported stolen to Miami Police Department. All three subjects were transported to Coral Gables Police Department for further investigation.

Further investigation revealed, Mr. Hernandez had a gray backpack that belonged to him in the trunk of the stolen vehicle. A search of the backpack revealed a total of 45 stolen credit cards in different names. Detective Rios contacted numerous victims who advised their credit cards along with other property were stolen from their possession. Mr. Carone was interviewed by CID Detectives and further investigation revealed that he was involved in a generator theft that took place at Harbor Freight Tools located at 1044 SW 67 Av. Miami Dade Police Department was contacted and arrested Mr. Carone for the theft.

Due to these collective efforts, the constant display of professionalism, and investigative tenacity, ensured the proper handling of this complicated case which resulted in the recovery of a stolen vehicle, solved multiple cases involving two different agencies and the apprehension of two subjects.

It is because of Officer Thomson's exceptional knowledge of the City's geography, the expediting of his rapid response and the tactical mindset approach to the incident location, that Officer Robert Thomson was able to swiftly apprehend these offenders. Therefore, it is with the

utmost respect and gratitude that I nominate Officer Robert Thomson for the prestigious award: "Officer of the Month."

NARRATIVE

On December 6, 2020, as I was patroling on SW Eighth St. eastbound, I was alerted via the City of Coral Gables Automatic License Plate Reader System (ALPR) a stolen vehicle of a black BMW bearing a FL Tag QBFV93 approximately 0858 hours. I observed the BMW in the 5100 of SW Eighth Street, then going westbound on Eighth Street, and making a left turn traveling southbound on Columbus Blvd. I followed the BMW until he turned into a residential driveway at 837 Columbus Blvd. I ordered the driver Lazaro Y. Hernandez (Offender) and the two passengers Yailen H. Fernandez (Involved Other) and Francisco V. Carone (Involved Other) out of the vehicle. At that moment none of them had an identification on them. I identified them through verbal communication and CGPD Teletype. I confirmed through CGPD Teletype the BMW was a stolen vehicle out of Miami PD (MPD Case 210105-0000962) and it was recorded stolen on January 5,2021. A records check revealed the defendant had a suspended driver license on February 24, 2020, for nonpayment of court financial obligation.

The offenders were handcuffed and transported to CGPD.

During the interview with Detective Rios, Mr. Hernandez stated, he had a gray backpack that belonged to him in the trunk of the stolen vehicle. Officer Thomson found a gray backpack in the trunk of the stolen vehicle. A search of the backpack incident to arrest revealed over forty credit cards in different person's name.

Mr. Hernandez had in his possession many credit cards that were in the name of other individuals. Detective Grigg (ID#10536) made contact with the following victims who advised their credit cards along with other property were taken from their possession without permission;

NARRATIVE

During an investigation of a stolen vehicle recovery (21000081), I found a generator in the back seat of a recovered stolen vehicle. Detective Rios interviewed the offender who told him he had purchased the generator at Harbor Freight located at SW 67 Av and SW Eighth Street. I contacted the loss prevention manager Richard Green who stated an unknown subject stole a generator at around 0830 hours on January 6, 2021. Video Surveillance indicated Mr. Carone, one of the passengers from the stolen vehicle above was the offender who stole the generator. I contacted Miami Dade Police who responded to Harbor Freight for a report and to arrest Francisco Carone (Involved Other). Miami Dade Police Case number is PD210106006232. Miami Dade Police Officer C Morales (9821) and Miami Dade Detective L Perez (7894) were on scene. A CGPD property receipt was completed.

Officer Guerra transported Mr. Carone from CGPD to 1044 SW 67 Av.
