**RESOLUTION AUTHORIZING EXECUTION OF A SECOND AMENDMENT TO THE EXISTING CONTRACT WITH SOUTH FLORIDA MAINTENANCE SERVICES, INC., ENTITLED "LANDSCAPE MAINTENANCE OF VARIOUS LOCATIONS IN THE CITY OF CORAL GABLES, FLA. DPS #2001-01", FOR THE PURPOSE OF ADDING MAINTENANCE LOCATIONS.**

**WHEREAS**, an existing contract that expires September 30, 2011, entitled "Landscape Maintenance of Various Locations in the City of Coral Gables, Fla. DPS #200101" between the City of Coral Gables and South Florida Maintenance Services, Inc., allows for the addition of sites to be maintained under the contract; and

**WHEREAS**, as a cost saving effort, it has become necessary to add additional locations to the list of sites currently maintained under the contract; and

**WHEREAS**, South Florida Maintenance Services, Inc. has for an additional annual cost of \$120,000.00, agreed to maintain the sites designated as part of Addendum No.2 as Attachment A;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby authorize the City Manager to execute a second amendment to the contract with South Florida Maintenance Services, Inc., entitled "Landscape Maintenance of Various Locations in the City of Coral Gables, Fla. DPS #2001-01", for the purpose of adding locations to the list of sites maintained under the contract.

**SECTION 3.** That the Second Amendment shall provide for an increase of \$120,000.00 annually for the maintenance of the additional sites.
