

**EXTENSION OF THE CONTRACT BETWEEN THE PARTIES TO  
PROVIDE THEATRE/DRAMA PROFESSIONAL SERVICESS**

This EXTENTION OF CONTRACT TO PROVIDE THEATRE/DRAMA PROFESSIONAL SERVICESS (“extension”) is made and entered as of the \_\_\_\_ day of \_\_\_\_\_, 2014, by and between The City of Coral Gables (“City”) and Miami Children’s Theatre, (“Professional”).

**RECITALS**

**WHEREAS**, the City and Professional have previously entered into a certain Contract dated May 28, 2009 (“contract”) whereby the Professional provides Theatre/Drama Professional Services at the Coral Gables War Memorial Youth Center; and

**WHEREAS**, the contract expired on May 28, 2014 and parties desire to extend the contract through December 31, 2014 (“the extension period”) to provide time for a Request for Proposal (RFP) process to be completed and for a new contract to be approved, and to authorize an extension of the existing contract; and

**WHEREAS**, the Professional has agreed to continue to provide Theatre/Drama Professional Services through an extension of the aforementioned contract for an additional period through December 31, 2014 under the same terms and conditions of the contract.

**NOW, THEREFORE**, in consideration of the promises and the mutual covenants contained herein, the City agrees to retain the Professional during the extension period.

1. **INCORPORATION OF RECITALS.** The foregoing recitals are true and correct and are incorporated herein. All terms used herein shall have the meaning ascribed to such terms in the contract, unless defined otherwise herein.

2. **TERM.** The parties hereby acknowledge that the extension period shall be May 28, 2014 through December 31, 2014, unless terminated earlier pursuant to the terms of the contract. Thereafter, the term will be automatically renewed on a month to month basis at the City’s option.

All other terms and provisions of the contract are hereby confirmed and shall remain in full force and effect, except as modified herein.
