### **ITEM TITLE:**

**Resolution.** A Resolution authorizing the acceptance and execution of the Fiscal Year 2020-2021 Emergency Medical Services (EMS) County Grant #C9013 Letter of Understanding and Agreement from the Miami-Dade County Board of County Commissioners and the State of Florida Department of Health; and amending the Fiscal Year 2020-2021 Annual Budget to recognize the \$1,386 grant award as revenue and appropriate such funds to cover the cost of the grant expenditures.

#### **DEPARTMENT HEAD RECOMMENDATION:**

#### **BRIEF HISTORY:**

The Florida Department of Health is authorized by Chapter 401, Part II, Florida Statutes to provide grants to Boards of County Commissioners for the purpose of improving and expanding pre-hospital emergency medical services. County grants are awarded only to Boards of County Commissioners but may subsequently be distributed to municipalities and other agencies or organizations involved in the provision of EMS pre-hospital care.

Miami-Dade County is responsible for the application and distribution process of the State EMS County Grant. The distribution of grant funds to each participating department is based on the percentage of combined total EMS calls for the calendar year prior to the new grant's fiscal year. The application for the FY 2020-2021 EMS County Grant #C9013 was approved by the Miami-Dade County Board of County Commissioners and the Florida Department of Health-Bureau of EMS. The grant in the amount of one thousand three hundred eighty-six dollars (\$1,386) has been approved for the City of Coral Gables' 2020-2021 work plan projects. Four hundred dollars (\$400) are allocated to purchase Emergency Medical Services Equipment, Materials, Supplies & Services and nine hundred eighty-six dollars (\$986) are allocated to pay for Conferences, Seminars & Training Sessions.

In order to qualify for the grant, the City of Coral Gables must approve a Letter of Understanding /Agreement which provides the basis for the disbursement and reporting responsibilities.

A budget amendment to the Fiscal Year 2020-2021 Annual Budget is required to recognize the \$1,386 grant award as revenue and appropriate such funds to cover the cost of the grant expenditures.
