ACTION REQUESTED BY THE BOARD/COMMITTEE:

The Insurance Advisory Committee is recommending that the City bind the renewal insurance proposal presented by Arthur J. Gallagher Risk Management Services, Inc. for insurance coverage with an effective date of May 1, 2010 to May 1, 2011.

Approve.


BRIEF HISTORY:

The City entered into a three year contract with two, two year renewal options that began on May 1, 2009 for Risk Management and Insurance Brokerage Services with Arthur J. Gallagher Risk Management Services, Inc. and AON Risk Services, Inc. of Florida after the City advertised RFP 2009.01.05 – Risk Management & Insurance Brokerage Services for the Property and Casualty Lines of Insurance Coverage. This RFP created a controlled platform for the City to obtain competitive bids on insurance broker service fees and competitive quotations on insurance policies (net of commissions) through a market assignment process. This is the second year of a three year contract with Arthur J. Gallagher Risk Management Services, Inc.



The savings in excess workers compensation is directly correlated to a reduction in payroll. The increase in excess liability and crime insurance premium is a direct result of a higher limits being purchased.
