B.-1. AiPP WAIVER REQUEST: REGENCY PARC

Developers representing the Regency Parc development project approached the Board with a waiver request of the Art in Public Places fee in lieu of placing public artwork on site. Artwork proposed by artist Lynda Benglis was presented.

The Board reviewed the proposal and were advised of the Arts Advisory Panel recommendation to approve the waiver request as presented. Board members commented enthusiastically about the work and artist. After a brief discussion the following motion was made:

A motion was made by Mr. Valdes-Fauli recommending approval of the waiver request from Regency Parc developers to commission and install artwork by Lynda Benglis at the project site as presented. Mr. Pantin seconded the motion, which passed unanimously.

G.-1. STRATEGIC PLAN – CULTURAL ARTS FOCUS AREA

Board members discussed the upcoming joint meeting with the Economic Development Board to address the City Commission resolutions regarding Cultural Arts as a focus area within the city's strategic plan.

Miami-Dade County Department of Cultural Affairs director, Marialaura Leslie, joined the meeting via Zoom and provided an overview of the county's recently adopted Arts Energize 305 plan. She stated that the plan is a "living" document and provided insight into working with the community to identify blind spots such as what can be done better, areas that are under-resourced or under-developed, who isn't being reached, and what the plan addresses over the next years to increase the social and economic impact of the arts throughout the County.

Rafi Maldonado, representing the Coral Gables Arts Alliance, attended in person and spoke on the interests of the Alliance and established cultural institutions in Coral Gables. He stated that the alliance includes representation of 18 organizations, including presenting facilities. Mr. Maldonado stated the importance of crafting a sustainable plan to support artists in the community and referenced the annual State of the Arts in Coral Gables happening the first Tuesday in December.

Board members were reminded that the meeting is scheduled for 8:30 a.m. on October 15th prior to their regularly scheduled monthly meeting.

G.-2. PRESENTATION OF A PROCLAMATION DECLARING OCTOBER 2024 AS "NATIONAL ARTS AND HUMANITIES MONTH" IN CORAL GABLES
