RESOLUTION NO. 2011-285

RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE SUPPLEMENTAL NO. TWO TO THE FLORIDA DEPARTMENT OF TRANSPORTATION JOINT PARTICIPATION AGREEMENT (JPA) NO. APF47 ENTERED INTO JUNE 16, 2009 BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION AND THE CITY OF CORAL GABLES TO REMOVE THE REQUIREMENT FOR LOW FLOORS IN TROLLEY PROCUREMENT SPECIFICATIONS AND EXTEND THE TIME FOR USE OF FINANCIAL ASSISTANCE (IN THE AMOUNT OF \$377,000) FOR THE PURCHASE OF TWO (2) NEW 30-FOOT LONG, HEAVY-DUTY, REPLACEMENT SHUTTLE BUSES FOR THE CORAL GABLES TROLLEY PROGRAM.

WHEREAS, in order for the Coral Gables Trolley Program to maintain current levels of service and provide for efficient and dependable transportation, it will be necessary to replace at least two (2) passenger shuttle buses estimated to cost \$755,282.00; and

WHEREAS, a Joint Participation Agreement (JPA) has been prepared by the Florida Department of Transportation for matching fund financial assistance in the amount of \$377,641.00 to fund a portion of the cost of purchasing two (2) new, heavy-duty shuttle buses; and

WHEREAS, the City has requested from FDOT to extend the completion date of this procurement from June 30, 2012 to June 30, 2013 and has requested that the low floor requirement be removed; and

WHEREAS, FDOT has agreed to the City's request through the attached supplemental No. 2 to the JPA allowing for removal of the low floor requirement and twelve (12) month extension for completion.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The City Commission authorizes execution of Supplemental No. 2. to Joint Participation Agreement No. APF47 with the Florida Department of Transportation to remove the low floor requirement and extend the time for use of financial assistance from June 30, 2012 to June 30, 2013 for procurement of two (2) shuttle buses to serve in the Coral Gables Trolley Program.


SECTION 3. This resolution shall become effective upon the date of its passage and adoption herein.
