[Note for the Record: Following Mayor Cason's reading the title to Agenda Item 1 (i.e., Presentation of a \$750.00 donation from the Coral Gables Woman's Club to the City of Coral Gables, to provide the Venetian Aquatic Club "Donna Perry Scholarship Fund" scholarships at the Venetian Pool), Mayor Cason introduced Ruth Martinez, First Vice President of the Coral Gables Women's Club and Robin Burr of the Venetian Aquatics Club. Vice President Martinez stated it's our pleasure to present this check to the Venetian Center Aquatic Club and we are very honored that they have been with us for many years, and our check is to provide scholarships for children who cannot afford swimming lessons. President Burr of the Venetian Aquatic Club said this year our donations allowed the Venetian Aquatic Club volunteers to award 24 scholarships, that was for 23 children and 1 adult, and part of that was matching funds from the City of Coral Gables in the amount of \$600 for a total donation of \$1,350 to the Donna Perry Memorial Venetian Aquatic Swim Scholarship Fund. She further stated the Venetian Aquatic Club has been teaching Red Cross Swimming and Safety classes since 1959. She further stated that this year we had over 140 volunteers who volunteered putting in over 5,000 hours teaching 1,097 lessons. President Burr, stated that as the Public Issues Chair for the Women's Club my focus is working with City leaders to coordinate these efforts and as President of the Venetian Aquatics Club for the second year she looks forward to overseeing the continued coordination of our efforts to better the community through outreach to children and adults, and teaching water safety.]

City Manager Swanson-Rivenbark asked Mark Trowbridge, President of the Coral Gables Chamber of Commerce and Javier Betancourt, City Economic Development Director, to come forward for this proclamation. Mr. Trowbridge recognized Coral Gables Chamber Chairman John Allen and Vice Chairman Bruce Bounds, who were in attendance and recognized the Chamber's partners, Javier Betancourt and Taciana Amador of the Business Improvement District. Mr. Trowbridge stated that the Chamber of Commerce is very excited about once again being one of the outstanding communities celebrating and supporting "Small Business Saturday," November 26th, the day after Black Friday, which creates 2/3rds of the jobs and contributes greatly to

the fabric of Coral Gables and small communities throughout our nation. Mr. Trowbridge thanked the City of Coral Gables for its great support over the last 6 years, providing our great municipal garages and operating the trolleys on Saturday and making it easy for the City to shop small. City Manager Swanson-Rivenbark stated that we should also use this opportunity to celebrate the appointment of the new Executive Director of the Business Improvement District (BID), Taciana Amador. Vice Mayor Quesada thanked the Chamber for the great job they have done over the past six (6) years with “Small Business Saturday” event, and added that Coral Gables retailers had been featured in commercials nationwide for American Express regarding “Small Business Saturday.”]

Presentation of a Proclamation declaring November 15, 2016 as "America Recycles Day" in Coral Gables.

[Note for the Record: Following Mayor Cason’s reading the title to Agenda Item 3 (i.e., Presentation of a Proclamation declaring November 15, 2016 as "America Recycles Day" in Coral Gables), he read the Proclamation. City Sustainability Coordinator noted the high amounts of electronic equipment that were collected at the electronics recycling event this weekend. Sustainability Board Member Marlin Ebbert stated that she always maintains that people want to comply with recycling, but you have to make it easy and we have made recycling easy for people, and added that it is all about getting the word out. Mrs. Ebbert stated that at this weekend’s event a large box of eye glasses were also collected, which will be given to those who do not have glasses available to them. Mrs. Ebbert said the next electronic recycling event is on Earth Day, but said she really gets asked about having a hazardous waste recycling, such as for paint and pool chemicals. City Manager Swanson-Rivenbark said that a hazardous waste pick-up is included in this year’s budget and we will be doing electronics recycling four (4) times per year. Commissioner Lago commended Mrs. Ebbert and the Sustainability Committee and the work of Assistant Public Works Director Jessica Keller and Sustainability Coordinator Matt Adams in making sustainability a main priority, and that Coral Gables has become the City to emulate with regard to sustainability. Commissioner Lago noted that “America Recycles Day” is this Saturday and with that he stated that 75 percent of waste can be recycled, but only 30 percent is actually being recycled and that plastic bottles are used by Americans in such quantity they can circle the earth four (4) times and that these bottles take 1,000 years to degrade. Commissioner Lago said lets enjoy “America Recycles Day,” and let's try as a community to set the bar higher and asked the Commission to empower the Sustainability Board, so that they can come up with great ideas like we have been having the last few years.]

Chief Hudak introduced Lieutenant Cordell Atherley who wrote the nomination for the Officer of the Month and Gold Medal of Valor. Lieutenant Atherley stated that this was a very special case and recounted the events that occurred on the afternoon Monday, September 12, 2016 involving a burglary and assault of two homeowners. Lieutenant Atherley stated without fear for his own life Officer Lopez apprehended the subject, a career criminal, who had entered a residence and was attempting to escape through a window, and in his twenty plus year career with the City this is a case that really stands out. Chief Hudak stated that this is something that Officer Lopez brings to the table every day and this is not the first time he has had these heroic actions. Chief Hudak stated that he really saved someone's life that day and that's the kind of officer we have in this department that makes him so proud to be their Chief. Officer Luis Lopez stated he really appreciate the recognitions that Lieutenant Atherley brought forth, and said it was a team effort and there was a huge response from everyone on the road, and thanked all of the officers for their efforts. Officer Lopez said he really he appreciated it, and thanked the Commission.]

[Note for the Record: Following Mayor Cason's reading the title to Agenda Item 6 (i.e., Congratulations to Lt. Jose Pereda, recipient of the City of Coral Gables "Firefighter of the Month Award," for the month of November, 2016), Mayor Cason asked Chief Marcos de la Rosa to introduce the "Firefighter of the Month." City Manager Swanson-Rivenbark stated that this meeting was Chief de la Rosa's first official City Commission Meeting as Fire Chief, Chief de la Rosa stated it was his distinct pride and pleasure to introduce the "Firefighter of the Month," as was stated in the previous item, we are in a unique position sometimes of having a significant impact on someone's life and today is one of those events. Chief de la Rosa stated Lt. Jose Pereda believed something didn't seem right about the patient, he had a gut feeling that you can't teach, its experience taking ownership of his call and being an

advocate of his patient; Lieutenant Pereda and his crew took the patient to the trauma center, and he shared his suspicions with the trauma center staff. Chief de la Rosa stated that it turned out within minutes of arrival to the trauma center; the patient was rushed into surgery to repair a ruptured major vein, which could have led to a loss of a limb or death.

Lieutenant Pereda thanked the Commission for this award and stated that this is not a call you train for and you don't have very much in your career. Lieutenant Pereda stated that this was not a typical trauma call, there was no injury present except for the small puncture wound in the lower abdomen and said that after we got her on the truck her blood pressure dropped dramatically, which gave him unease that something was not right. Lieutenant Pereda stated we made the right decision as a crew on this call, the other members of the team could not be here, but this was team effort, it's not just me. Lieutenant Pereda then introduced the patient on this call, Cristina Baldor.

Ms. Baldor stated she wanted to share her perspective about the call, and that she had been on a bike ride and suddenly she found herself in the dirt, feeling the worst pain of her life, and she called 911 for help. Ms. Baldor stated she wanted to have on the record that she was not a good patient, not seeing anything visibly wrong and that Lieutenant Pereda was her advocate when she could not be, and he knew that I needed to go to the Trauma Center, which likely saved my life. Ms. Baldor said there is nothing adequate that you could say to someone who saved your life, and how extraordinary a person must be to choose to live their life saving the most vulnerable among us, no matter how dirty, grumpy and uncooperative they are. Ms. Baldor stated she was proud to be here to see Lieutenant Pereda recognized by his department and City. She thanked Lieutenant Pereda on behalf of the University of Miami, Jackson Memorial Hospital and her family.]

Also, I wanted to congratulate the Manager, you know the Miami Today has their Book of Leaders for 2016, and in going through this Book of Leaders, it is impressive to see how many of the people that are here are actually business people or residents of our City, but in addition to that, our Manager was named the Leader of the Year for Government, so I'd like to

congratulate her on that, it was well deserved.

Commissioner Lago: I want to wish everybody a Happy Thanksgiving, Happy and Safe Thanksgiving. I hope everything works out and that everybody enjoys time with their family. I want to request from Assistant City Manager Fernandez that he highlight the NSA's and give us an update. I'm hearing great things from the residents. I hear crime is down in reference to the petty crimes that are going on, that were going on, excuse me. I'd also like to bring to the attention of the City Manager and staff and to everyone one here, we are having an issue with quorum in regards to the Waterway Advisory Board. My appointment is the Chairman.
