As part of an ongoing effort to enhance the health, safety, and welfare of the citizens of Coral Gables, a recent inspection was made to the premises at:

At that time, a Code Enforcement Officer found the following violation(s) evident on the property:

Floors, walls, ceilings and roofs - Sec. 105-278. - Floors, walls, ceilings and roofs. Floors, walls, ceilings and roofs of every structure used for human habitation shall be structurally sound, and maintained in a clean and sanitary condition. They shall be free from cracks, breaks, loose plaster and similar conditions so serious as to endanger the safety of occupants or to seriously mar the attractiveness of the premises. Code Enforcement Officer Comments: Property walls, facia's, overhangs are dirty and discolored. Peeling paint on facia and missing paint and plaster on walls.

Must clean walls, overhangs, decorative border. Must plaster where missing. Must paint facia, walls, where missing. Must obtain all approvals and permits necessary to complete work.


