Dear Mayor Lago:

The Florida Department of Commerce (FloridaCommerce) has reviewed the proposed comprehensive plan amendment for the City of Coral Gables (Amendment No. 23-01ESR) received on August 30, 2023. The review was completed under the expedited state review process. We have no comment on the proposed amendment.

The City should act by choosing to adopt, adopt with changes, or not adopt the proposed amendment. For your assistance, we have enclosed the procedures for adoption and transmittal of the comprehensive plan amendment. In addition, the City is reminded that:

- Section 163.3184(3)(b), F.S., authorizes other reviewing agencies to provide comments directly to the City. If the City receives reviewing agency comments and they are not resolved, these comments could form the basis for a challenge to the amendment after adoption.
- The second public hearing, which shall be a hearing on whether to adopt one or more comprehensive plan amendments, must be held within 180 days of your receipt of agency comments or the amendment shall be deemed withdrawn unless extended by agreement with notice to FloridaCommerce and any affected party that provided comment on the amendment pursuant to Section 163.3184(3)(c)1., F.S.
- The adopted amendment must be transmitted to FloridaCommerce within ten working days after the second public hearing pursuant to 163.3184(3)(c)2., F.S. Under Section 163.3184(3)(c)2. and 4., F.S., the amendment effective date is 31 days after FloridaCommerce notifies the City that the amendment package is complete or, if challenged, until it is found to be in compliance by FloridaCommerce or the Administration Commission.

Pursuant to Section 163.3184(3), Florida Statutes (F.S.), in its role as a reviewing agency as identified in Section 163.3184(1)(c), F.S., the Florida Department of Transportation, District Six, reviewed the proposed text amendments to the City of Coral Gables' Comprehensive Plan. The proposed amendments modify text within the Future Land Use Element to increase maximum building heights for commercial land uses and industrial land uses with parks incentives if developed pursuant to the Design & Innovation District Regulations. An additional amendment is proposed for industrial land uses to be granted an additional 25% floor area ratio for properties qualifying as receiving sites for transfer of development rights (TDRs).

The District reviewed the amendment package per Chapter 163 Florida Statutes and found the proposed text amendment would not adversely impact transportation resources and facilities of state importance.

Please be advised that the City of Coral Gables Local Planning Agency (Planning & Zoning Board) held a duly advertised public hearing for amendments to the City's Comprehensive Plan on July 12, 2023 for the below proposed amendments. The Future Land Use element amendments received a recommendation for denial (3-2) from the Local Planning Agency on July 12, 2023. Per Section 14-102.3. of the City's Zoning Code, the failure to obtain 4 affirmative votes to amend the Comprehensive Plan shall be deemed a recommendation of denial of such amendment.

On August 22, 2023, the Local Governing Body (City Commission) also held a duly advertised public hearing and approved (3-2) the attached proposed amendments. This letter constitutes transmittal of all relevant documentation by the City to the Department of Economic Opportunity (DEO) for review under the expedited state review process.

The proposed ordinance (agenda item E.6.) is attached along with a copy of the City Commission agenda and meeting minutes showing Commission action. (See Attachment 1)

The proposed amendments revise the Future Land Use Element of the City of Coral Gables Comprehensive Plan pursuant to Zoning Code Article 14, "Process," Section 14-213, "Comprehensive Plan Text and Map Amendments," to provide additional building height up to one hundred and thirty-seven feet and six inches with parks incentives if developed pursuant to the Design & Innovation District Regulations. The proposed amendments also clarify the Design & Innovation District as a Transfer of Development Rights Receiving Area.

We have included agenda memos and staff reports for your review (See Attachment 2), noting that in the Planning & Zoning Board Staff report, the specific Comprehensive Plan Review and Analysis are located on pages 2-4. Public notice documentation is also provided.
