**RESOLUTION NO. 2008-06 (AS AMENDED)**

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES SUPPORTING THE EFFORTS OF THE BUDGET/AUDIT ADVISORY BOARD IN FURTHERANCE OF A PROPOSED CHANGE TO THE COUNTY ROAD IMPACT FEE ORDINANCE; FURTHER SEEKING SUPPORT FROM OTHER MIAMI-DADE COUNTY MUNICIPALITIES TO CHANGE THE DISBURSEMENT PROCESS, THUS PROVIDING A LOCAL OPTION TO RECEIVE FUNDS DIRECTLY INSTEAD OF NEGOTIATING WITH THE COUNTY THE FUNDING AND SCOPE OF MUNICIPAL PROJECTS; FURTHER AUTHORIZING THE CITY MANAGER TO PROCEED WITH TALKS WITH MIAMI-DADE COUNTY MANAGER, GEORGE BURGESS REGARDING THE BACKGROUND PARAMETERS IN CONNECTION THEREWITH; FURTHER ALSO DESIGNATING COMMISSIONER RAFAEL "RALPH" CABRERA TO REPRESENT OUR COMMISSION REGARDING COMMUNICATION WITH MIAMI-DADE MEMBERS OF THE COUNTY COMMISSION (INCLUDING, BUT NOT LIMITED TO THOSE COUNTY COMMISSIONERS, WHO REPRESENT OUR DISTRICT, NAMELY, CARLOS GIMENEZ, REBECCA SOSA) ALONG WITH MIAMI-DADE COUNTY MAYOR CARLOS ALVAREZ IN ARTICULATING THE CITY'S POSITION REGARDING SAID MATTER; FURTHER REQUESTING THAT UPON CONCLUSION OF SAID COMMUNICATIONS BETWEEN THE CITY AND THE ABOVE REFERENCED COUNTY OFFICIALS, THAT THE AFOREMENTIONED CITY OFFICIALS SHALL REPORT BACK TO OUR CITY COMMISSION FOR FURTHER CONSIDERATION AND REVIEW OF SAID MATTER.

**WHEREAS**, Miami-Dade County Road Impact Fee Ordinance provides for the County to collect and manage the Road Impact Fees for the individual municipalities; and

**WHEREAS**, each municipality must apply to the County for those projects that may qualify for these fees; and

**WHEREAS**, at the present time there is a approval procedure in place for the disbursement of the Road Impact Fee for each project within the municipalities; and

**WHEREAS**, Miami-Dade County charges an administrative fee for such services; and

**WHEREAS**, the City is reimbursed for the expenditures of the approved projects; and

**WHEREAS**, the City of Coral Gables desires a local option to receive funds directly instead of negotiating the funding and scope of these projects;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption hereof.

**SECTION 2.** That the City Manager is hereby authorized to proceed with talks with the County Manager regarding said proposal to change the Miami-Dade County Road Impact Fee Ordinance to provide a local option to receive funds directly instead of negotiating with the County the funding and scope of municipal projects.

**SECTION 3.** That said resolution shall become effective upon the date of its passage and adoption herin.
