APPROVAL OF THE MINUTES

MEMBERS SHARE INPUT FROM RESIDENTS

- Annexation - Are there new plans to annex Little Gables? Staff responds that there are no current plans,
- North Ponce Median Update - Staff responds that the project is scheduled to begin this month and will take approximately 1 year to complete

UPDATES FROM BOARD MEMBERS ON CURRENT PROJECTS

- Walk Safe:
 - o A Coral Gables High School (CGHS) student was recently struck while at the crosswalk by a car on Ponce de Leon Blvd. and Bird Road.
 - o The crosswalk at Altara and Le Jeune needs to be adjusted, or a left green arrow added. Currently cars get the green light at the same time that pedestrians get the walk signal allowing conflicts to occur. This is the same intersection a UM student was killed last year.
 - o Update Walk Safe in strategic plan to be specific to area. Board member Kurzner to provide language.
 - o Police to enhance the patrol to help traffic and provide safe crossings.
 - o Staff to provide update from PW on timeline, funding, and scope of work for area west of CGHS to align with Strategic

Plan.

- Motion to request Public Works and DCM to work with County to adjust crosswalk timing so pedestrians have a dedicated time to cross separate from green light to cars. Leymarie motions, Snow seconds.

- North Ponce - Swale Guideline Revision:

- The Swale Guidelines have been revised to include the typical street section found in North Gables. The item is on the September 25, 2025 Commission Meeting Agenda, deferred from the September 10, 2025 Commission Meeting
- Board would like to notify property owners, via mail or email

- Satellite Launch:

- Next steps, once Strategic Plan has been adopted, is to find partnerships with educational and private companies

- Border Signage:

- Selection of architect and engineer is pending. Once design is finalized Board member Snow will bring it before the council when available.

UPDATES ON CITY INITIATIVES

- Mayor's 2025-2027 Strategic Plan, revisions:

- Priority #2 - Revise customer satisfaction survey to include as a follow up to specific services
- Priority #3 - Utilize voter rolls to inform electorate of upcoming ballot questions
- Priority #4 - Reorganize section to separate accomplishments from Next Steps. Revise language regarding Walk Safe to include specifics (Board Member Kurzner to provide). Revise business community goal to include increasing visibility
