## **RESOLUTION NO. 2025-326**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF TECHNOLOGY OFFICER AUTHORIZING AN ENTERPRISE LICENSE AGREEMENT WITH ESRI, INC., FOR THE PURCHASE OF CITY-WIDE ACCESS AND UNLIMITED DEPLOYMENT OF GIS PRODUCTS AND SERVICES IN THE ESTIMATED AMOUNT OF \$147,000 PURSUANT TO SECTION 2-689, SOLE SOURCE PROCUREMENT OF THE PROCUREMENT CODE.

**WHEREAS**, the City of Coral Gables, through the Gables GIS section, in the Innovation and Technology (IT) department, has previously engaged with ESRI Inc. for an Enterprise Agreement for GIS software services, and has been using ESRI GIS products for analyzing geographic information for over twenty (20) years; and

**WHEREAS**, the maps, web applications, dashboards and derivative charts and displays produced by Gables GIS have served the City's decision-making processes and presentation needs; and these processes and presentations support important City operations; and

**WHEREAS**, the City of Coral Gables desires to continue with the advanced capability now provided through cloud services, and other enhanced GIS services and features for enterprise applications, crime analysis, sustainability management, facilities management, public notice, smart devices, mobile services, data analytics, and cloud computing; and

WHEREAS, ESRI is the sole-source provider of these GIS services; and

WHEREAS, an enterprise agreement with ESRI offers significant cost avoidance over piecemeal license acquisition; and

**WHEREAS**, the IT department has the need to renew the annual maintenance of the ESRI ELA for a period of three (3) years at \$49,000.00 per year or in an amount not exceed the available budget; and

**WHEREAS**, the Chief Procurement Officer has determined that ESRI is the sole source provider of GIS Products and services under Section 2-689 of the Procurement Code; and

**WHEREAS**, Section 2-650 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2**. That the City Commission accepts the recommendation to authorize an enterprise license agreement with ESRI, Inc., for the purchase of on-going City-wide access and unlimited deployment of GIS products and services as long as the services are required in an estimated amount of \$147,000 or not to exceed the available budget pursuant to Section 2-689, Sole Source Procurement, of the Procurement Code.

**SECTION 3**. That this Resolution shall become effective upon the date of its passage and adoption herein.
