

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2008-94**

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER PURSUANT TO REQUEST FOR PROPOSAL (RFP) TO SELECT WEATHERTROL MAINTENANCE CORPORATION, AS THE PROVIDER OF CITYWIDE HEATING VENTILATION AIR CONDITIONING SERVICES, AT A NOT TO EXCEED AMOUNT OF \$57,000.00 PER YEAR; FURTHER AUTHORIZING THE CITY MANAGER TO SIGN AND EXECUTE A CONTRACT FOR A TWO (2) YEAR PERIOD WITH AN OPTION TO RENEW FOR AN ADDITIONAL THREE (3) ONE (1) YEAR PERIODS.

**WHEREAS**, Procurement formally advertised and issued a Request for Proposal (RFP) for Citywide Heating Ventilation Air Conditioning Services on June 27, 2007, and distributed the RFP to five (5) prospective bidders; and

**WHEREAS**, on August 2, 2007, Procurement received six (6) responses to the RFP from All Comfort Co., Johnson Controls, Thermo Air Inc., A&M Mechanical, Weathertrol Maintenance Corp. and Temptrol Air; and

**WHEREAS**, Weathertrol Maintenance Corporation will be providing Citywide Heating Ventilation Air Conditioning Services in accordance with the specifications, terms, and conditions detailed in the City's RFP; and

**WHEREAS**, this service will be funded by the Public Works Department, Maintenance Division budget year 2007-2008 and subsequent budget years through the end of the contract;

NOW THEREFORE BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.


**SECTION 2.** That the City of Coral Gables Commission does hereby accept the recommendation of the City Manager, approving the decision to select Weathertrol Maintenance Corporation for Citywide Heating Ventilation Air Conditioning Services, not to exceed amount of \$57,000.00 per year, for a two (2) year period, with an option to renew for an additional three (3) one (1) year periods.

**SECTION 3.** That all resolutions or parts of resolutions inconsistent with, or in conflict herewith, shall be and are hereby repealed insofar as there is conflict or inconsistency.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
