## **RESOLUTION NO. 2019-342**

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE AND INCREASE THE SPENDING AUTHORITY ON THE ELECTRICAL CONTRACTOR SERVICES CONTRACT WITH AGC ELECTRIC, INC. IN THE ESTIMATED AMOUNT OF \$1,652,000 PURSUANT TO SECTION 2-501(D) OF THE CITY'S PROCUREMENT CODE.

**WHEREAS**, on May 7, 2019 a competitive solicitation was issued to establish a contract for citywide electrical contractor services; and

**WHEREAS**, the award for the services was made to AGC Electric, Inc., on July 5, 2019 under the City Manager's award authority; and

WHEREAS, the contract was awarded to accommodate work that includes troubleshooting and correcting problems in electrical systems of any size and voltage both indoors and outdoors, general electrical maintenance and repair, new service installations, emergency repair work, roadway and overhead streetlights and other electrical related work; and

WHEREAS, AGC was the lowest priced bidder based on the hourly rate offered for the services and the award amount was calculated by the estimated number of hours utilized during the year as determined by Facilities; and

WHEREAS, subsequent to the award, Public Works identified other projects that should be performed under the contract; and

**WHEREAS**, the additional work consists of the following potential projects: 1-Garage No. 2 lighting replacement to LED; 2- Indoor LED lighting in City Facilities; 3-Whiteway Lights; 4- Cocoplum Phases I & II and; 5- City-owned LED streetlight conversion; and

WHEREAS, the City Commission finds that utilizing this existing contract is in the City's best interest and will allow Public Works will be able to expedite these key projects;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission, pursuant to Section 2-501(d) of the City's Procurement Code, waives the requirements of the Procurement Code and approves that the additional work in the estimated amount of \$1,652,000 be performed under the existing contract with AGC Electric, Inc. because it is in the best interests of the City to utilize the existing contract.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
