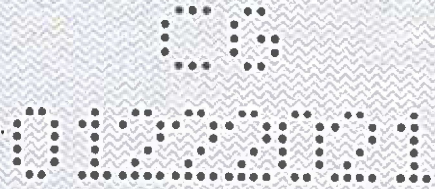

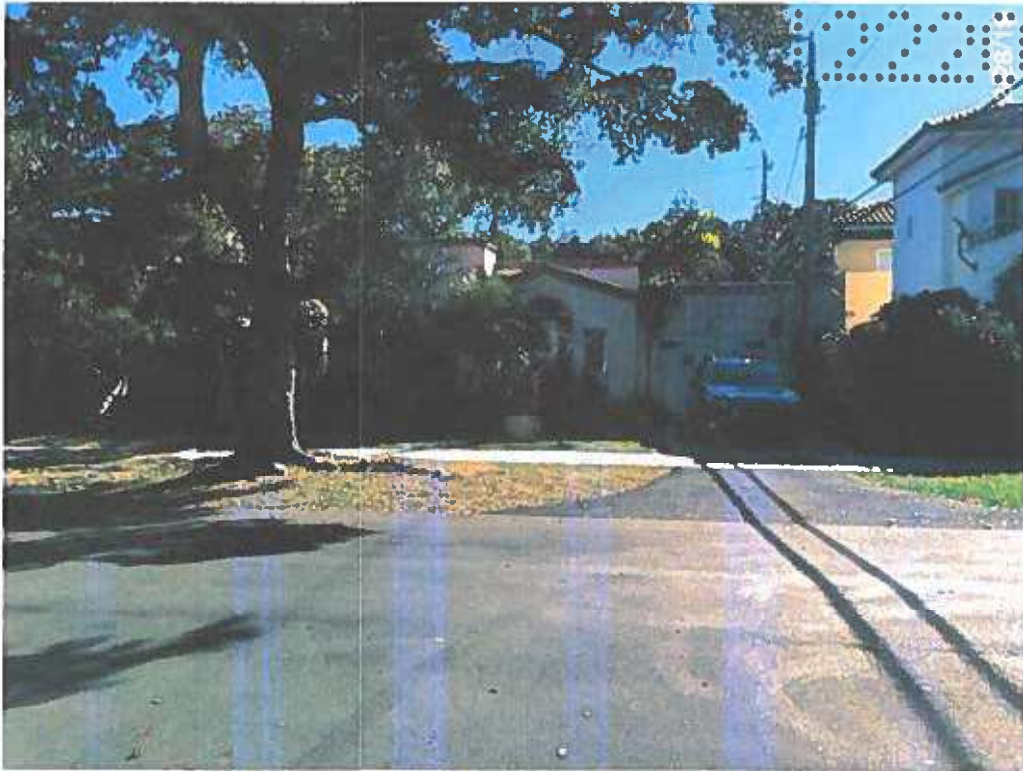


EXISTING ROOF CONDITIONS AT 6913 TALAVERA STREET CORAL GABLES, FL

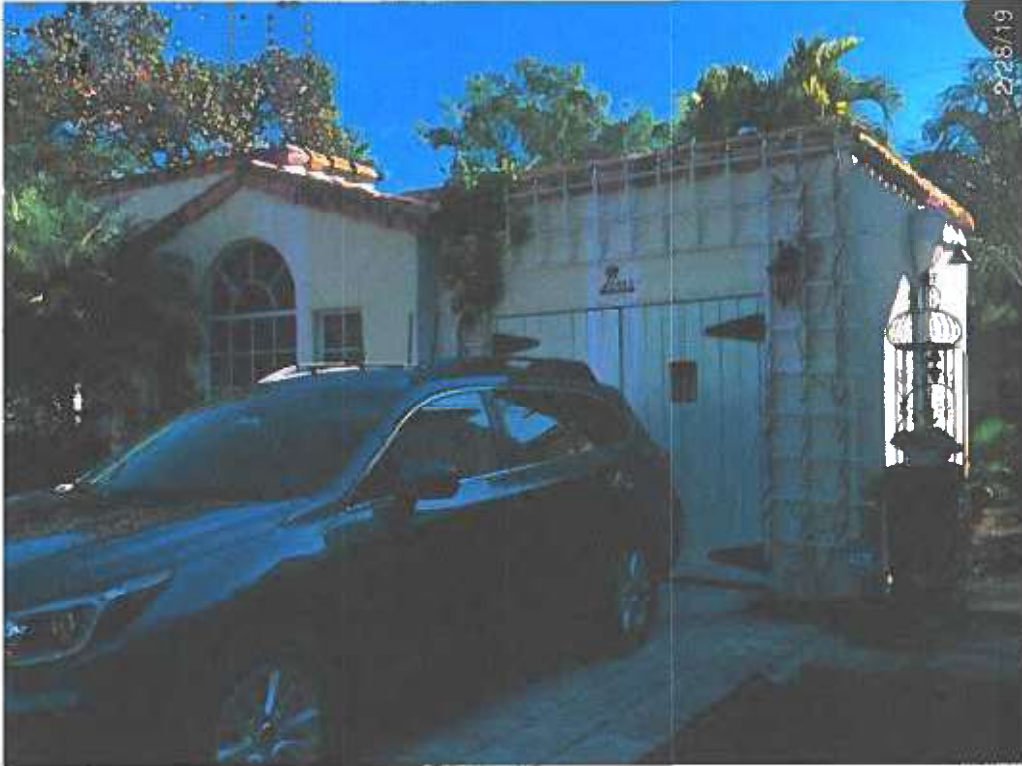
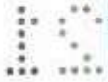
