CASE FILE LHD 2023-004: Consideration of the local historic designation of the property at 1207 Genoa Street, legally described as Lot 1, Block 34, Coral Gables Granada Section Revised, according to the Plat thereof, as recorded in Plat Book 8, at Page 113, of the Public Records of Dade County, Florida.

A motion was made by Ms. Bache-Wiig, seconded by Mr. Ehrenhaft, to approve the Local Historic Designation of the property located at 1207 Geno Street. The motion passed unanimously.

VII. SPECIAL CERTIFICATES OF APPROPRIATENESS:

1. CASE FILE COA (SP) 2019-001 REVISED: An application for the issuance of a Special Certificate of Appropriateness for the property at 1417 Obispo Avenue, a Contributing Resource within the Obispo Avenue Historic District, legally described as Lot 36, Block 18, Coral Gables Section "E," according to the Plat thereof, as recorded in Plat Book 8, at Page 13 of the Public Records of Miami-Dade County, Florida. The application requesting design approval for design approval for additions and alterations to the residence, construction of a two-story auxiliary structure, and sitework was approved by the Historic Preservation Board on March 21, 2019. The applicant is requesting approval for a variance from Section 2-101 D (4) c and Section 2-101 D (5) of the Coral Gables Zoning Code for the auxiliary structure's minimum rear setback.

A motion was made by Ms. Spain, seconded by Ms. Rolando, to grant a variance to allow a two-story accessory structure to have a rear set back of approximately 5 feet, where 10 feet is required according to Section 2–101 D-4 (c) and Section 2–101 D-5 of the Coral Gables Zoning Code. The motion passed unanimously.
