On December 30th, 2020, at approximately 12:07 AM, Sergeant Jesus Rodriguez (ID #8456) was working an off-regular-duty security detail inside the gated Gables Estates community when G4S Security officers notified him that two suspicious (2) black males, wearing hoodies and dark colored pants were observed on their live-feed closed circuit television (CCTV) surveillance camera system. The suspicious males appeared to be looking at high-end luxury vehicles parked in the private residential driveways along the 300 block of Arvida Parkway.

Sergeant Rodriguez immediately became concerned and advised all on-duty uniform patrol units over the Police Main radio channel what the G4S Security officers had told him and requested Dispatch to send additional units to saturate the area. Several units responded and began saturating the area where the suspicious males were last seen as Sergeant Rodriguez remained with G4S Security to monitor the live-feed CCTV system and relay any new or critical information to the uniform patrol units who were looking for the suspicious males.

At approximately 12:45 AM, two (2) G4S Security officers went to make sure 280 Arvida Parkway was secure because the homeowner was out of town. Upon entering the backyard, they encountered one of the suspicious males hiding in the bushes. The G4S Security officers advised over their radios that they had the male detained at gunpoint and requested police assistance. Upon hearing this, Sergeant Rodriguez immediately advised Dispatch to send any available patrol units to assist the G4S Security officers on a "3". Several responded and placed the male into custody without incident. Miranda was read and the male admitted that he had been dropped off on Old Cutler Road with another black male, who was wearing all black clothes.

Based on the aforementioned events, circumstances and information, Sergeant Rodriguez knew it was only a matter of time before the second suspect attempted to leave the gated community, so he decided to remain nearby the Gables Estates guardhouse for the rest of his tour of duty to monitor any vehicles coming into or going out of Gables Estates, as well as coordinate with G4S Security who were monitoring the live-feed CCTV system.

At approximately 3:20 AM, G4S Security were monitoring the live-feed CCTV system when they advised Sergeant Rodriguez that they observed the second suspect walking along the 300-BLK of Arvida Parkway. Several CGPD units responded to Arvida Parkway but the suspect saw

them approaching and went back into hiding. Sergeant Rodriguez was more determined than ever to locate the suspicious male, so he continued monitoring any vehicles coming in or going out of Gables Estates, and the suspicious male apparently had no choice but to remain hiding inside Gables Estates for the remainder of the night.

At approximately 7:30 AM, Sergeant Rodriguez was informed by G4S Security officers that they had just observed the suspicious male on live-feed CCTV, leaving a residence located at 705 Arvida Parkway. The suspect then pretended to be jogging westbound, towards the main entrance/exit/security guard house on Arvida Parkway. Sergeant Rodriguez waited patiently for the suspicious male to approach the guard house and immediately placed him into custody without further incident.

I truly believe that on this evening, several Coral Gables residents would have had their vehicles burglarized and/or stolen, if it were not for Sergeant Rodriguez's determination and tenacity. Additionally, I believe that both subjects were apprehended in this case because Sergeant Rodriguez took it upon himself to collaborate with G4S Security, monitor their live-feed CCTV system, monitor their radio transmissions and relayed critical information over the Police Main radio channel to on-duty patrol units.

For these reasons, I respectfully request that Sergeant Jesus Rodriguez be considered for the CGPD Officer of The Month Award for December 2020.

**NARRATIVE**

On Wednesday, December 30, 2020, at approximately 12:08 am, I was dispatched to the 300 Block of Arvida Parkway in reference to 3 black male suspects seen casing the area. Numerous CGPD units responded to the area and began to search the surrounding properties. After several minutes, G4S Security guard (Lowe W-1) advised he was out in the rear of 280 Arvida Parkway with one black male subject that matched the description of one of the subjects originally seen on the security video. CGPD units responded to the rear of the property and assisted G4S in securing the suspect. The suspect was later identified as (Juvenile). The suspect was read his Miranda Rights per card by Officer Rosson. Post Miranda, Juvenile admitted he was dropped off from Old Cutler Road by an unknown vehicle with a second suspect. The juvenile described this second suspect as a black male wearing an all black sweater, black pants, and short cropped hair. He would not disclose this second suspects name to us. When asked why they were dropped off in the area, the juvenile advised he did not wish to answer any more questions.

Juvenile could not dispel our alarm as to why he was in the gated community hiding from CGPD Officers behind the privately owned residence post Miranda, and he could not provide a valid reason.

Contact was made with the victim (Alonso) and she advised that no one should be on her property. She further advised that she did not know Juvenile and he had no permission to be on her property.

A BOLO was issued for the second suspect still at large that did in fact match the video description of the suspect captured with the juvenile on the security cameras.

CID Detectives Rios (K604) and Det. Flores (K-602) responded to the scene. Sgt. Rodriguez (A300) and Sgt. Koppel (A-100) was present on the scene.

The juvenile was transported to CGPD for questioning by CID.

Juvenile was provided water and offered restroom breaks while in custody.

Juvenile was processed here at CGPD then transported to the Juvenile Assessment Center.

Note: contact was made with the Juvenile's mother and she was advised of the situation.

Gables Estates G4S Security notified Coral Gables Police of 2 black males casing the area of the 300-block of Arvida Parkway. The 2 males were seen on surveillance cameras wearing hooded sweatshirts and dark colored pants.

CGPD Units responded to the area and began to search for the suspects. A few minutes into the search G4S Security officers advised they were out in the rear of 280 Arvida Parkway with a black male suspect. CGPD units responded to the rear of this property and located the co-offender and took him into custody. The co-offender was identified as a juvenile.

The other black male remained inside Gables Estates Community, throughout the night and was seen on surveillance footage exiting the property of 705 Arvida Parkway at approximately 7:30 a.m. and then proceeds to jog towards the security guard house, located at 800 Arvida Parkway, where he was confronted by G4S security and me. The offender was identified as Mr. Kenneth Lazarre and was immediately placed into custody as he matched the description of the BOLO and video surveillance footage. A voice-mail was left with the homeowner at 705 Arvida Parkway informing him of the trespass.

The offender was read his Miranda Rights per signed form by Detective David Grigg ID #10536. Post Miranda, the offender admitted he was inside Gables Estates Community walking. The offender advised that he did not know anyone in the area. When questioned further by CGPD Detectives, he advised that "I just want to go." When question about the juvenile co-offender, he claimed he did not know him; despite video surveillance revealing both males walking together.

The offender had entered upon the property without authorization from the victim with the intent to commit a crime thereon.

The offender could not dispel our alarm as to why he was in the gated community hiding from CGPD officers behind a privately-owned residence. Post Miranda Rights the offender could not provide a valid reason.

The offender was processed here at CGPD and then transported to TGK via CGPD processing.

On 12/30/20, Detective Cruz (8374) and I conducted an interview with Mr. Kenneth Saint Clair Lazarre. The interview was on the third floor of the Coral Gables Police Department CID interview room. Mr. Lazare was read his rights per form and agreed to speak to us. He stated that he knew he was being charged for trespassing. He advised that he is from Ft. Lauderdale and does not know anyone who lives in the area. Mr. Lazarre stated that he was, "just walking". He advised that he does not know the juvenile co-defendant that was arrested earlier in the night. Video surveillance, which was attained by Sgt. J Rodriguez (#8456), shows both the defendant and co-defendant walking together throughout the neighborhood. Another video attained by Sgt. Rodriguez shows the defendant leaving the property of 705 Arvida Parkway in the morning hours. I attempted to call the property owner and was only able to leave a voice-mail requesting contact. The defendant claimed that he did not have a cell phone despite having a cell phone charger on his persons. The defendant became agitated during the course of the interview and advised that he just wanted to go. He did not offer any answers for further questioning.

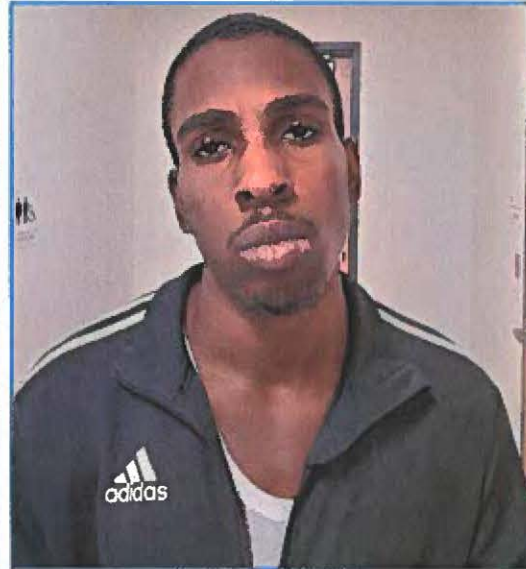
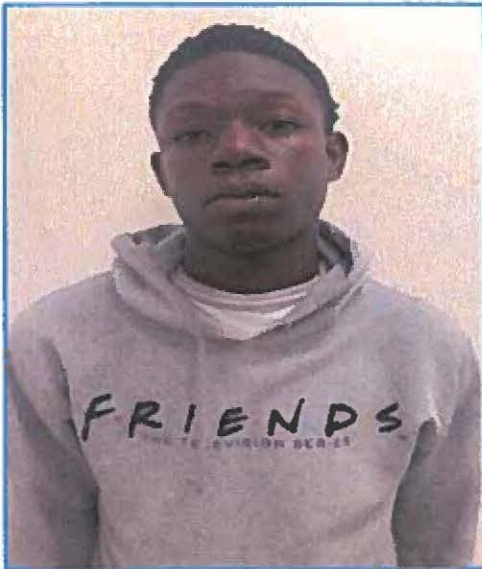
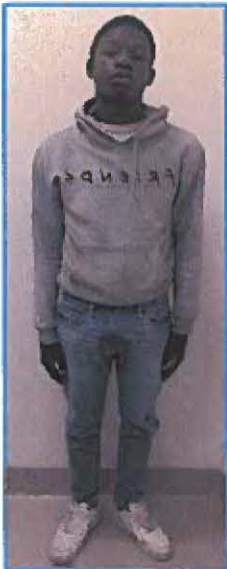
