SECTION 5. The Finance Director is hereby authorized to expend the aforesaid funds for the De Soto Fountain Pump Room and Restoration Project from matching grant from the Florida Department of State, Division of Historical Resources, assisted by the Florida Historical Commission and \$242,000.00 from the City's (Capital Improvement Program) CIP.

SECTION 6. This Resolution shall become effective upon the date of its adoption herein.

RESOLUTION NO. 2006-139

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE A PROFESSIONAL SERVICES CONTRACT WITH KEYSTONE RESTORATION, INC., THE NUMBER ONE-RANKED VENDOR RECOMMENDED BY THE COMPETITIVE SELECTION COMMITTEE FOR THE DE SOTO FOUNTAIN PUMP ROOM AND RESTORATION PROJECT, AND DESIGNATING FUNDS THEREFORE IN AN AMOUNT NOT TO EXCEED \$484,000.00, FROM A MATCHING GRANT FROM THE FLORIDA DEPARTMENT OF STATE, DIVISION OF HISTORICAL RESOURCES, ASSISTED BY THE FLORIDA HISTORICAL COMMISSION IN THE AMOUNT OF \$242,000.00 AND \$242,000.00 FROM THE CITY'S (CAPITAL IMPROVEMENT PROGRAM) CIP.

WHEREAS, pursuant to the provisions of its Charter, the City advertised and received three responses on April 17, 2006 to the Request for Qualifications. Two of the three responding firms were certified by the Certification Committee. On June 9, 2006, the Competitive Selection Committee recommended the following firms in ranking order for final consideration:

1. Keystone Restoration, Inc.
2. C. A. Lidman, Inc.

NOW, THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. The foregoing "WHEREAS" clause is hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The findings and recommendations of the Competitive Selection Committee are hereby ratified and approved.

SECTION 3. The City Manager is hereby authorized to negotiate and execute a contract with the number one-ranked firm by the Competitive Selection Committee, Keystone Restoration, Inc., in an amount not to exceed \$484,000.00, for the De Soto Fountain Pump Room and Restoration Project, designating funds therefore in the amount of \$242,000.00 from the Florida Department of State, Division of Historical Resources, assisted by the Florida Historical Commission and \$242,000.00 from the City's Capital Improvement Program (CIP).
