A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD RENTAL OF HEAVY EQUIPMENT TO EQUIPMENTSHARE.COM INC., THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, PURSUANT TO INVITATION FOR BIDS (IFB) 2025-011 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

- **WHEREAS,** on May 8, 2025, the Procurement Division of Finance formally advertised, issued and distributed the IFB for Rental of Heavy Equipment; and
- **WHEREAS**, Twenty-nine (29) prospective bidders downloaded the IFB package from Infor, the City's web-based e-Procurement service; and
- **WHEREAS**, on June 13, 2025, two (2) bids were received in response to the IFB 2025-001 from EquipmentShare.com Inc. and United Rentals (North America), Inc.; and
- **WHEREAS**, the Procurement Division finalized its' due diligence process and confirmed that EquipmentShare.com Inc., is both responsive to the requirements of the IFB and a responsible bidder.
- **WHEREAS**, the Chief Procurement Officer recommends to award Rental of Heavy Equipment to EquipmentShare.com Inc.; and
- **WHEREAS,** Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on contract awards.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **Section 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **Section 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager to award Rental of Heavy Equipment to EquipmentShare.com Inc., the lowest responsive and responsible bidder for an initial three (3) year term with two (2) one-year renewals in an amount not to exceed the available budget pursuant to Invitation for Bids (IFB) 2025-011 and section 2-763 of the procurement code entitled "Contract Award".
- Section 3. That this resolution shall become effective upon the date of its adoption herein.
