ACTION/ RECOMMENDATION

I respectfully nominate Officer Alejandro Pino, #11429, for Officer of the Month Award for February 2021.

BACKGROUND

On February 6, 2021, at approximately 5:04 p.m., units responded to 1119 Cotorro Av, in reference to an unknown black male with a suitcase that jumped the fence of the residence. A perimeter was established and a BOLO (Be On the Look Out) was issued for a black male, approximately 5'04" to 5'06" feet tall, 120-140 pounds, wearing a hoodie, black shirt with "University of Miami" logo and orange sleeves, black pants, black shoes, wearing a black and green backpack, and holding a dark suitcase. The residence at 1119 Cotorro Av, was checked by officers. After clearing the residence (currently vacant and being renovated), it was confirmed a residential burglary occurred, with forced entry (rear broken window). The dark colored suitcase was located inside of the residence (see Case 21-000679).

At approximately 9:07 p.m., a second call was received at 6100 Caballero St (apartment building), of a male matching the offender's description looking into windows in the back of the apartment building (see Arrest Affidavit/report Case 21-00681). Police units responded in emergency mode and a perimeter was established. The apartment building is located on the waterway. I took a perimeter point at S Alhambra Circle/S Dixie Hwy (1390 S Dixie Hwy, rear of the business, with a visual of the waterway). I observed a black male, dressed in dark clothing fleeing on foot from the rear of 6100 Caballero, towards the docks. The offender began to head south, then as the illumination of emergency lights (red and blue) illuminated of the residence just south of 6100 Caballero St, the offender abruptly changed direction and started running north bound along the docks (towards S Dixie Hwy). Officer Pino sprang into action without hesitation, running down the stairs (located at the south alley of S Dixie Hwy) towards the offender. He confronted the offender head-on, gave verbal commands and took him into custody without further incident. A black and green backpack was located in a trash bin, within feet of where the offender was taken into custody. Officer Pino transported the offender to Coral Gables Police Headquarters (2151 Salzedo St), where he was interviewed by detectives. The male (offender) waived his rights to counsel and provided a full confession. He admitted to entering the victim's residence (1119 Cotorro Av) through a rear window. He used a rock to break the

window (causing \$800 in damage). He also stated that he was not renting the victim's residence and it was wrong for breaking into the residence. Detective Flores showed several photographs of the recovered from the suitcase and contents (from 1119 Cotorro Av), and a photo of the black/green bookbag (which contained an orange shirt and the black "UM" logo shirt) laying in the trash bin (located behind 6100 Caballero St). The offender stated that it was his bookbag.

Officer Pino has been with Coral Gables Police Department (CGPD) for only 1 year and 5 months. However, he has 5 years of prior law enforcement experience with Florida Highway Patrol (FHP). During the short time period that he's been here (CGPD), he's proven to be a very proactive officer with keen observation skills, who always strives to serve the community with professionalism. Officer Pino is assigned to the Uniform Patrol Division (UPD), currently assigned to Alpha shift. On February 6, 2021, he was working overtime on Charlie shift, prior to his regular tour of duty. Officer Pino continues to demonstrate he is an asset to the agency, and it has been a pleasure to work with and supervise him (even if it's only been while he's working on overtime or overlap between shifts) during this past year!

Officer Pino's knowledge of the area (alleyway access/stairway leading to the dock/waterway), experience, and ability to engage the subject led to the apprehension and arrest of this violent career criminal (see Criminal Investigations Division BOLO #21-039). There is no doubt this subject would have continued victimizing our residents, damaging and depriving them of their property had Officer Pino not intervened. Therefore, I believe Officer Alejandro Pino is deserving of the Officer of the Month Award for February 2021.

NARRATIVE

On February 06, 2021 at approximately 1704 hours, I responded to 1119 Cotorro Av, in reference to an unknown black male with a suitcase that jumped the fence of the residence.

Upon arrival, I made contact with Mr. Erick Ralph Eckblom (Reporting Party). Mr. Eckblom stated that at approximately 1654 hours, he observed a black male (Offender) walking eastbound on the 1100-Blk of Cotorro Av. Mr. Eckblom stated that the Offender was holding a large "black" rolling luggage. Mr. Eckblom stated that the Offender made his way to the driveway of 1119 Cotorro Av and placed his luggage by the front door. Mr. Eckblom then stated that the Offender continued walking eastbound towards Turin Street and then lost sight of him. The Offender then returned to 1119 Cotorro Av and made his way to the rear of the residence with the luggage. Mr. Eckblom then advised that the Offender threw the luggage over the gate (chain link fence, waist height) and then jumped over into the backyard. Mr. Eckblom then observed the Offender exit out of the front door of 1119 Cotorro Av. Mr. Eckblom advised that the Offender observed patrol units in the area and then made his way back inside the front door. Mr. Eckblom then advised that the Offender then jumped the rear gate of the residence (northbound), fleeing towards an unknown direction shortly after.

Offender description: Black male, approximately 5'04"-5'06" feet tall, 120-140 pounds, wearing a hoodie, black shirt with University of Miami logo and orange sleeves, black pants, black shoes, wearing a black and green backpack and holding a dark colored suitcase.

I issued a Be On The Look Out (BOLO) through dispatch for the male.

Further investigation revealed an open rear sliding door and a broken/open rear window (estimated damage \$800) with signs of force.

K-9 Officer Owens responded and cleared the residence.

A perimeter was set up and revealed negative results.

Crime Scene Tech J. Garcia responded and processed the scene.

Ms. Lilibet Regueiro (Involved Other 1/Victim's wife) responded and advised that no one should have been inside of the residence. Mr. Lord Michael Toussaint (Victim) advised that they (he and his wife) will secure the window at a future date. The rest of the residence was secured. Ms. Regueiro advised that there is nothing missing from the residence. Ms. Regueiro advised that the house is currently vacant and under construction. Mr. Toussaint advised that he could not respond to the scene because he is hosting an event.

The luggage that was left on scene by the Offender was impounded in the CGPD property section by Officer J. Tillery. The luggage contained the following: inflatable air mattress, bed sheets, pillow, green hard hat, and a green bag with miscellaneous toiletries.

A case number was given to the Victim and a watch order was placed.

At approximately 2107 hours, I responded to the rear of 6100 Caballero Blvd, in reference to a black male wearing a backpack looking into multiple windows (Case #21-000681). A black male matching the same BOLO'ed description (from 1119 Cotorro Av) was given by the caller. The black male fitting the BOLO'ed description was located and taken into custody by Officer A. Pino. The black male spontaneously stated, "Am I getting my green and black backpack back?" Inside the green and black backpack was an Adidas black knit polo shirt with a University of Miami "U" logo on it and a long sleeve orange shirt. The clothing in the backpack matched the same clothing description from the Offender from 1119 Cotorro Av. Further investigation revealed that the black male in custody was the same Offender from 1119 Cotorro Av. The black male was identified as Mr. Desmond Anthony Riley, Jr (Offender).

Cross Reference Case #21-000681.

Detective E. Flores (8459) and R. Mardis (10449) responded and interviewed Mr. Riley (see supplement). Detective Flores read Mr. Riley, Jr., Miranda Warnings per form. Mr. Riley, Jr. (Offender), waived his legal rights to counsel and agreed to speak to detectives. Mr. Riley, Jr., said once inside 1119 Cotorro Av, he stated that he turned on the heater of the residence, using the electricity of the Victim without his permission.

Mr. Riley was arrested and transported to TGK by Officer A. Pino.

On Saturday January 6, 2021 at approximately 5:21 PM, I was dispatched to 1119 Cotorro Av, reference a possible residential burglary. Upon arrival, I made contact with Ofc. Ortega (C108) who stated that a witness observed a black male carrying a suitcase jump over the locked chain-link fence of a vacant duplex and enter the duplex through the rear. Upon police arrival the witness stated the male exited through the rear and ran toward Mariposa Av. An exterior search of the duplex revealed a smashed out bedroom window and a rear sliding door open. I then retrieved my canine partner Kaiser to conduct an interior search of the duplex to clear the apartment.

Once at the rear sliding door, I feed Kasier on a fifteen foot lead into the entrance and gave two loud and audible canine announcement in English and Spanish. Waiting for approximately five seconds and hearing no response I then conducted an interior search of the apartment keeping Kaiser on a fifteen foot lead. Kaiser and I searched the entire apartment with negative results. During my search I discovered the large suitcase the witness described the subject had with him in the livingroom area. The scene was then turned over to the patrol officers to complete their investigation.

On February 6, 2021 at 9:29 PM, I, Detective Emilio Flores, was assigned a burglary incident that occurred at 1119 Cotorro Avenue. Mr. Lord Michael Toussaint was notified of the incident. The Victim's residence is undergoing renovation.

On February 6, 2021 at 1704 hours, Mr. Eric Ecknlom (Witness) saw Mr. Riley Desmond (Offender) in front of the residence, looking around the residence, throw the luggage over the fence, jump the fence, open the front door, and then run from the rear of the residence prior to police arrival. Mr. Eric Ecknlom described Mr. Riley Desmond and provided clothing description (UM Logo Shirt/ Orange/ black shirt and pants/ black shoes with a backpack). Mr. Riley Desmond ran northbound from the Victim's residence. At approximately 9:07 PM, a second call was received of a male matching Mr. Riley Desmond's description looking into windows at the apartment building located at 6100 Caballero Blvd (See report 21-000681). Mr. Riley Desmond was arrested and transported to the police station. Detective R. Mardis (ID#10449) and I interviewed Mr. Riley Desmond at the Police Station/Criminal Division. The interviewed was recorded. I advised Mr. Riley of his Miranda Rights, and he waived his rights to remain silent and his right to counsel and agreed to speak with Detective R. Mardis and I.

Mr. Riley Desmond admitted entering the Victim's residence (1119 Cotorro Avenue) by the rear window. He used a rock to break the window (\$800). He entered the victim's residence to sleep. He also stated that he turned on the heater and was going to inflate his air mattress (which was located inside the suitcase). He stated that he was not renting the Victim's residence and it was wrong for breaking into the residence. He opened the front door and saw police units arriving to the scene. Mr. Riley Desmond then ran out through a back door and hid by a trash can. I showed several pictures of his personal belongings he left before running out of the Victim's residence. He admitted leaving his blue luggage containing several personal items i.e., green bag with personal hygiene products. When he ran out of the Victim's residence, he took his green/black backpack, which also contained other personal property.

A search incident to arrest revealed inside his bookbag an orange shirt and a black UM shirt. Mr. Riley Desmond threw his book bag inside a trash bin (See report 21-000681). I showed him a picture of the backpack in the trash bin and he stated that it was his backpack.

Mr. Riley Desmond was transported to TGK via CGPD processing.

Detective R. Mardis completed Arrested BOLO 21-039.

February 8, 2021- I called the owner of the credit card found on Mr. Riley's possession, but it revealed negative results (718-746-7819). Mr. Riley stated the credit card belong to a male friend, but the owner is a female. Credit Owner: Fern Minsky.

I gave Mr. Riley a small pack of Girl Scout cookies and water.

Crime Scene Technician J Garcia Veliz responded and processed the crime scene.

On Saturday January 6, 2021 at approximately 5:21 PM, I was dispatched to 1119 Cotorro Av, reference a possible residential burglary. Upon arrival, made contact with Ofc. Ortega (C108) who stated that a witness observed a black male carrying a suitcase jump over the locked chain-link fence of a vacant duplex and enter the duplex through the rear. Upon police arrival the witness stated the male exited through the rear and ran toward Mariposa Av. An exterior search of the duplex revealed a smashed out bedroom window and a rear sliding door open. I then retrieved my canine partner Kaiser to conduct an interior search of the duplex to clear the apartment.

Once at the rear sliding door, I fed Kasier on a fifteen foot lead into the entrance and gave two loud and audible canine announcement in English and Spanish. Waiting for approximately five seconds and hearing no response I then conducted an interior search of the apartment keeping Kaiser on a fifteen foot lead. Kaiser and I searched the entire apartment with negative results. During my search I discovered the large suitcase the witness described the subject had with him in the livingroom area. The scene was then turned over to the patrol officers to complete their investigation.

NARRATIVE

On February 06, 2021 at approximately 2107 hours, I responded in emergency mode to 6100 Caballero Blvd in reference to a black male wearing a backpack in the rear of the apartment building looking into windows.

The description given by Ms. Jessica Posada (Reporting Party) matched the same description of a prior incident that occurred on the same date at approximately 1904 hours (see Case#21-000679).

Upon arrival, Sgt. L. Poole (8222) took a perimeter point at the corner of South Alhambra Circle and South Dixie Hwy. Sgt. L. Poole then had a visual on the black male (Offender) which matched the BOLO'ed description given by Ms. Posada at the rear of 6100 Caballero Blvd, near the boat docks. Sgt. L. Poole observed the black male walk down the stairs (from the rear of the apartment building) towards the dock/waterway and then walk westbound on the sidewalk along the dock. Sgt. Poole then observed the black male turn around (Red and blue police lights could be seen reflecting off the building, just west of 6100 Caballero Blvd) and begin to walk eastbound on the sidewalk along the docks, towards S. Dixie Hwy. At this point, Sgt. Poole observed the black male (wearing a backpack) start running eastbound towards S. Dixie Hwy. Sgt. L. Poole then gave the black male loud verbal commands (while simultaneously shining her flashlight in the direction of the black male), "Police stop, Stop running, get on the ground," but the black male disregarded Sgt. L. Poole's commands. Officer A. Pino (11429) ran towards and down the stairway that led to the dock, where he intercepted the fleeing black male near the stairwell, while telling the black male "Let me see your hands, get on the ground." The black male stopped running and complied to Officer Pino's verbal commands and was taken into custody.

While conducting our investigation, Officer A. Pino asked the black male, "What is your name and date of birth?" The black male replied, "My name is King Desmond and my date of birth is August 20, 1992."

Further investigation revealed that the black male gave us a false name. The black males real name is Desmond Anthony Riley, Jr. Further investigation also revealed that Mr. Riley Jr, was the same Offender from 1119 Cotorro Av (Case#21-000679). Mr. Riley Jr. was transported to Coral Gables Police Headquarters. While in the holding cell at CGPD, I conducted a search of the Offender's shoes yielding a piece of glass (right shoe). The broken glass appeared to match the same glass from the rear broken window at 1119 Cotorro Av (see Crime Scene Photos).

Detective E. Flores (8459) and Detective R. Mardis (10449) responded and interviewed Mr. Riley. Detective Flores read Miranda Warnings and he agreed to speak with Detectives (see supplement). Post Miranda, Mr. Riley admitted to looking into windows and knocking on doors to find a place to sleep. Mr. Riley stated that he is not from the area and gave the Detectives an address of 5720 Nw 21 Av, Miami, FL, 33127. Mr. Riley was arrested and charged for the aforementioned crimes.

On January 6, 2021, I, Detective Emilio Flores, was assigned a resisting without violence incident that occurred at 6100 Caballero Blvd. Police units responded to the above location about a suspicious male call. Upon the officers' arrival, they saw Mr. Desmond Riley (Offender) matching the description of the burglary incident that occurred at 1110 Cotorro Avenue (21-000679). Crime Scene Technician J Garcia-Veliz responded to the scene and recovered the offender's black/green backpack inside a trash bin. Mr. Riley was transported to the Police Station/Criminal Division for an interview. The interview was recorded. I advised Mr. Riley of his Miranda Rights, and he waived his rights to remain silent and his right to counsel and agreed to speak with Detective R. Mardis and I.

He ran when he saw police overhead lights.

I gave Mr. Riley a small pack of Girl Scout cookies and water.




