

#### STRATEGIC FOCUS AREAS, OBJECTIVES & GOALS

#### 1 – Customer-focused Excellence: Provide exceptional services that meet or exceed the requirements and expectations of our community.

- 1. Attain world-class performance levels in overall community satisfaction with city services
  - 1. Attain overall and safety focused questions on the community satisfaction score of XX% satisfied / very satisfied by 2023 / XX% by 2025 (**Solanch**)
  - 2. Attain/sustain 90<sup>th</sup> percentile on transactional surveys within departments by 20XX (parks, sanitation, permitting, emergency services, etc.) (**Solanch**)
- 2. Attain world-class performance levels in public safety
  - 1. Maintain at least 90th percentile overall satisfaction score with fire rescue services (**De La Rosa**)
  - 2. Maintain at least 90th percentile performance level for response time of fire / EMS (**De La Rosa**)
  - 3. Achieve police response time of 90% of responses within 9 minutes of call for non-emergency and 5 minutes for emergency calls by 2025 (**Hudak**)
  - 4. Maintain at least 90th percentile performance for crime rates (USC) within the state of Florida for similar size cities (**Hudak**)
  - 5. Reduce crash rates by 5% annually (**Hudak**)
- 3. Improve mobility and safety throughout the city by reducing the intensity of traffic
  - 1. Increase utilization rate of alternative modes of transportation by 6% by 2025 (**Kevin**)
  - 2. Increase satisfaction with city transit services to 95% satisfied / very satisfied by 2025 (Kevin)
  - 3. Decrease high incidence rate locations of correctable vehicle-pedestrian accidents, pedestrian injuries, and falls by 50% by 2025
  - 4. Implement a wayfinding program by 2025 (include historic sites) (**Kevin**)
- 4. Enhance our position as a premier destination for arts, culture, dining, and shopping
  - 1. Increase residents who are who are satisfied / very satisfied with the downtown experience by 5% by 2023, and by 25% by 2025 (Warren)
  - 2. Increase pedestrian counts to historical sites, art, and cultural events and for dining and shopping by XX% by 2025 (Warren)

### 2 - Workforce-focused Excellence: To be the organization of choice by attracting, training, and retaining a competent and cohesive workforce.

- 1. Ensure sufficient workforce capacity to deliver high quality results
  - 1. Maintain less than 10% workforce vacancy rate (Karla)
  - 2. Increase workforce retention rate to 75% overall by 2025 (Karla)
  - 3. Achieve parity in pay grades at 105% 110% of market pay range (compensation plans at 5% to 10% above midpoint compared to other comparable municipalities) (**Karla**)
- 2. Attain world-class levels of performance in workforce satisfaction and engagement
  - 1. Attain workforce engagement score of 75% by 2025 (Karla)
  - 2. Attain workforce satisfaction score regarding communication (75%), recognition (75%), Opportunity for growth (75%) and immediate supervisor (75%) by 2025 (**Karla**)
- 3. Ensure appropriate workforce training, professional development opportunities, leadership skills, and advancement opportunities
  - 1. Attain 80% very satisfied with training, education, and certification opportunities provided by 2025 (**Karla**)
  - 2. Achieve satisfaction scores in transactional evaluations of 80% at each training event by 2025 (Karla)
  - 3. Increase internal promotion rates to 20% for leadership and management opportunities by 2025 (**Karla**)

- 4. World-class performance levels in workforce health and safety
  - 1. Reduce Restricted Time (DART) rate to 0.XX% by 2025 (Raquel)
  - 2. Increase participation rate in wellness programs to 25% by 2025 (Karla)

  - 2. Implement citywide paperless processes and digital efficiencies by 2023 (Raimundo)
  - 3. Implement smart and connected districts, buildings, and facilities (broadband) by 2025 (**Raimundo**)
- 2. Increase the efficiency of key resource utilization and service processes
  - 1. Implement an Enterprise Standard Operating Procedure Library & System by 2023 (**Raimundo**)
  - 2. Improve efficient use of electricity by 20% KW/H per square foot over 2015 consumption levels, gasoline consumption by 5%, and water by XX% per square foot of building and open space by 2025(**Hermes**) reduce water loss by irrigation by XX% over 2022 baseline by 2025

  - 2. Increase participation rates with the historical and cultural components in programs offered by the city to the community by 5% by 2025 (Warren)
- 2. Promote appropriate development and economic growth by retaining, expanding, and recruiting businesses
  - 1. Increase the number of business tax licenses that complement the brand by 25% by 2025 (**Julian**) (action plan to include identification of the types of businesses that complement the brand, based on the economic study being completed)
  - 2. Design and implement storefront and signage guidelines including Façade Improvement by 2023 (**Julian**) (metric will be compliance with new guidelines)
- 3. Promote world-class neighborhood experience
  - 1. Increase the percentage of geographic areas within 10-minute walk of a park, playground, or other recreational space to at least 85% by 2025 (**Fred**)
  - 2. Provide dog parks for the community to meet the top ten benchmark City national standard for dog parks by 2025
  - 3. Provide a fully operational Country Club for residents achieving 80% operating cost recovery by 2025 (Fred)

- 4. Enhance the sense of community through educational offerings to meet the needs of residents and small businesses
  - 1. Provide 2 new offerings annually to address identified needs in technology, literacy, innovation, and business development annually (**Fred**)

# 6 – Sustainability-focused Excellence: Provide exceptional services that enhance the local and global environmental ecosystem, enrich our local economy, and strengthen the health and well-being of residents, businesses, and visitors.

- 1. Increase the resiliency of the city
  - 1. Maintain fleet operational readiness rate of at least 90% based on class of vehicle (Steve)
  - 2. Maintain information technology systems uptime rate of 99.9% (Raimundo)
- 2. Support the use of environmentally friendly practices.
  - 1. Increase electric vehicles in the fleet to 72 by 2025 (**Steve**)
  - 2. Increase electric charging stations to 120 by 2025 (**Kevin**)
  - 3. Increase the utilization of Street LED lighting to 85% and City Facilities to 70% by 2025 (Hermes)
  - 4. Increase monitoring capability from 2 to 9 sensors by 2025 in order to analyze, understand, and efficiently improve water quality (**Raimundo**)
  - 5. Increase monitoring capability from 5 to 16 sensors by 2025 in order to analyze, understand, and efficiently improve air quality (**Raimundo**)
  - 6. Maintain at least 40% tree canopy (**Deena**)
  - 7. Maintain a recycling contamination rate below 13% (Hermes)
