RESOLUTION NO. 2009-98

A. RESOLUTION APPROVING THE DECISION OF THE CITY MANAGER TO REJECT ALL PROPOSALS RECEIVED FOR CITY-WIDE SECURITY GUARD SERVICES.

WHEREAS, following the recommendation issued by the Interim City Manager, a Written Protest was filed on March 9, 2009 on behalf of World International Security; and

WHEREAS, World International Security was determined by the Procurement Division to be a non-responsive bidder resulting from their failure to acknowledge an Addendum to the IFB; and

WHEREAS, pursuant to Section 2-950(g) of the City's Procurement Code, the Chief Procurement Officer issued a written recommendation to the Interim City Manager that the written protest from International Security be denied as a result of World International Security's failure to acknowledge Addendum 1; and Addendum 1 was important to the evaluation of the bid as it provided answers to 30 questions from other bidder; and

WHEREAS, on Wednesday, March 26, 2009, a hearing was held by the Interim City Manager to hear the Bid Protest submitted by the attorney representing World International Security; and

WHEREAS, at the March 26, 2009 hearing, World International Security raised the following points regarding the issue: failure to acknowledge the addendum was merely a clerical or scrivener's error; addendum was not material to the bid; and addendum was merely a summation of the security services contract; and

WHEREAS, under Section 2-950(g), Authority to Resolve Protests, the City Manager may either resolve the protest or reject all proposals;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES AS FOLLOWS:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby approve the decision of the City Manager to reject all proposals received for City-wide Security Guard Services.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.




