1. Approval of December 11, 2019 Meeting Minutes

Mr. Manrara made a motion to approve the meeting minutes and Mr. Lowell seconded the motion, which passed unanimously. There were no discussions regarding the minutes.

2. Asset Manager Report

3501 Granada Blvd. Update

Ms. Sardinas updated the board that the house is under contract at \$1.9M and is not located on the golf course as discussed in the previous meeting. The 1947 house has historic landmark designation and includes a two-car garage and a guest house.

Ms. Sardinas reviewed the rent report with board members which shows that every tenant is in compliance with their payments.

3. Pop-Up Incubator Program Update

Ms. Valdes reported that "Artist Jorge De La Torriente" was the successful artist selected for the program. Mr. De La Torriente is the owner of the *De La Gallery* to be located at 290 Miracle Mile. An opening date has not been set but Ms. Valdes will inform the board members. The 850 sq/ft space will be leased for a 6-month period with an option for an additional six months renewal at the City's sole discretion.

4. Open Discussion

Ms. Valdes was sad to announce the French pastry shop *Madeleine & More* closed down after being open for one month.

Mr. Mazzei made a motion to pursue a negotiation of a one year extension with Patio & Things that was seconded by Mr. Manrara, which passed unanimously.

Mr. Lowell requests a report from the Cinema to be made showing how their fundraising efforts are going.

For future meetings, the Board expressed interest in having updates provided by city staff, elected officials and community stakeholders.

There being no further discussion the meeting was adjourned at 9:36 a.m.
