RESOLUTION NO. 2020-143

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO WAIVE THE COMPETITIVE BID PROCESS OF THE PROCUREMENT CODE PURSUANT TO SECTION 2-691 ENTITLED "SPECIAL PROCUREMENT/BID WAIVER" FOR THE LEASE OF ELEVEN (11) 2020 FLHP HARLEY-DAVIDSON MOTORCYCLES FROM PETERSON'S HARLEY-DAVIDSON OF MIAMI, LLC., FOR A TWO (2) YEAR PERIOD.

WHEREAS, the City's current lease for the 2018 Harley-Davidson FLHP motorcycles from Peterson's Harley-Davidson of Miami, LLC will expire in August 14, 2020; and

WHEREAS, Peterson's Harley-Davidson of Miami proposes a new lease agreement to replace the eleven (11) 2018 Harley-Davidson motorcycles for the Police Department's Special Enforcement Division/Motor Unit with new 2020 models; and

WHEREAS, the 2020 models cost \$625 per motorcycle, per month, for a two (2) year period in the amount of \$165,000.00 commencing upon the City's acceptance of delivery of the last new motorcycle under the new agreement; and

WHEREAS, Section 2-691 of the Procurement Code entitled "Special Procurement/Bid Waiver" authorizes the Procurement Officer to initiate a special procurement/bid waiver when an unusual or unique situation exists that makes the application of all requirements of competitive sealed bidding or competitive sealed proposal contrary to the public interest; and

WHEREAS, Section 2-585 of the Procurement Code entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer pursuant to Section 2-691 of the Procurement Code entitled "Special Procurement/Bid Waiver," for the lease eleven (11) 2020 Harley-Davidson FLHP motorcycles from Peterson's Harley-Davidson of Miami, LLC., for a two (2) year term with a total lease amount of \$165,000 for all leased motorcycles, subject to final approval and execution of a lease agreement by City staff.

SECTION 3. This Resolution shall become effective upon the date of its passage and adoption herein.


