**RECOMMENDATION OF THE CITY MANAGER:**

The City Manager recommends approval.

**BRIEF HISTORY:**

This is a special event request for Fritz and Franz Bierhaus to celebrate *BLUESFEST* in Coral Gables. This request is to serve alcoholic beverages during the celebration and is in compliance with the laws of the State of Florida.

In regard to *BLUESFEST* hours, they will be open outside on Friday from 4:00 pm. until 11:00 pm, Saturday 11:00 am to 11:00 pm, and Sunday from 11:00 am to 8:00 pm.

These hours are for the activity outside of the licensed restaurant area and include the live music and public plaza activities. Normal operating hours and activities will remain the same for operations within the licensed business site. In addition, a code enforcement officer will be on hand to supervise the noise level of the event. The officer will keep communication with central dispatch, will be aware of any noise complaints made and will take any steps needed to manage the noise level.
