RESOLUTION NO. 2024-54

A RESOLUTION OF THE CITY COMMISSION RENAMING THE CITY OWNED PROPERTY CURRENTLY NAMED SUNRISE HARBOR PARK LOCATED AT 25 SUNRISE AVENUE IN HONOR OF SALLYE AND JAMES JUDE WHO WERE BOTH LONG-TIME COMMUNITY ACTIVISTS AND WHOSE CONTRIBUTIONS LED TO THE ADVANCEMENT OF MODERN MEDICINE, WITH THE NAME "THE JAMES AND SALLYE JUDE PARK."

WHEREAS, the City Commission adopted a revised park naming policy via Resolution No. 2020-237; and

WHEREAS, the park naming policy allows the City Commission to nominate individuals for a naming honor and to waive any part of the parking naming process at their discretion; and

WHEREAS, the City Commission unanimously recognized via Resolution No. 2023-265 that Sallye Jude and Dr. James Jude are extraordinary individuals who have each contributed to the fabric of the City and that it is appropriate and fitting for a park to be named after them; and

WHEREAS, Sallye Garrigan was born in Baltimore, Maryland in 1926 and married Dr. James Jude in 1952; and

WHEREAS, Dr. James Jude's work at Johns Hopkins University pioneered the research that led to the development of CPR; and

WHEREAS, Dr. James Jude's national recognition brought the Judes and their family to Miami in 1964 where Dr. Jude became the Chief of Thoracic and Cardiovascular Surgery at the University of Miami School of Medicine and at Jackson Memorial Hospital; and

WHEREAS, Sallye Jude became an active and integral part of the community through her involvement with the medical wives' group, her church, and in her children's schools; and

WHEREAS, Sallye Jude is credited with being part of the small group that founded the Dade Reading Foundation – one of the earliest programs in Miami-Dade County for learning for children with disabilities; and

WHEREAS, The Community Recreation Department together with the input from Marlin Ebbert and the Jude family, has identified Sunrise Harbor Park located at 25 Sunrise Avenue, Coral Gables, FL 33134 as the park designated to be named after Sallye and James Jude; and

WHEREAS, this name designation is in accordance with the City's Park Naming Policy and has been reviewed and recommended with a unanimous vote by the Parks & Recreation Advisory Board;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That Sunrise Harbor Park located at 25 Sunrise Avenue, Coral Gables, FL 33134, be named "The James and Sallye Jude Park."

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.




