## **RESOLUTION NO. 2025-310**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD **IMPROVEMENTS** TO DRAINAGE **GPE** ENGINEERING & GENERAL CONTRACTOR CORP., AS THE PRIMARY RESPONSIVE AND RESPONSIBLE BIDDER, AND FG CONSTRUCTION, LLC, AS THE SECONDARY RESPONSIVE AND RESPONSIBLE BIDDER, IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS, PURSUANT TO INVITATION TO BIDS (IFB) 2025-026 AND SECTION 2-763 OF THE PROCUREMENT CODE CITY'S **ENTITLED** "CONTRACT AWARD".

**WHEREAS**, on June 23, 2025, the Procurement Division of Finance formally advertised, issued and distributed IFB 2025-026 Citywide Drainage Improvements; and

**WHEREAS**, on July 1, 2025, a non-mandatory pre-bid conference was held, and two hundred and three (203) prospective bidders were notified through INFOR, the City's web-based e-Procurement system.; and

**WHEREAS**, on July 22, 2025, four (4) bids were received in response to the IFB 2025-026 from: David Mancini & Sons, Inc., FG Construction, LLC, GPE Engineering & General Contractor Corp., Inc., and Metro Express, Inc.; and

WHEREAS, the Public Works Department concurs with the Procurement Officer's recommendation to award GPE Engineering & General Contractor Corp., as the primary responsive and responsible bidder, and FG Construction, LLC, as the secondary responsive and responsible bidder for a two (2) year term contract with option to renew for three (3) additional one (1) year periods, in an amount not to exceed budgeted funds; and

**WHEREAS,** Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager to award the Citywide Drainage Improvements contract to GPE Engineering & General Contractor Corp., as the primary responsive and responsible bidder, and FG Construction, LLC, as the secondary responsive and responsible bidder for a two (2) year term contract with option to renew for three (3) additional one (1) year periods, in an amount not to exceed budgeted funds pursuant to Section 2-763 of the Procurement Code entitled "Contract Award" and Invitation for Bids (IFB) 2025-026.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
