3. Lifetime Achievement Award

Ms. Ramudo congratulated Mr. Perez for receiving the American Planning Association's Oliver Kerr Lifetime Achievement Award.

4. Incentives Discussion

Mr. Julian Perez provided the Board with a presentation regarding incentives. Mr. Perez explained the purpose of incentives, described the types of incentives (intrinsic/extrinsic), and listed and explained the most common incentives (tax, financial, rebate, subsidies, negative incentives, and cash grants). He also categorized specific incentive programs by the agency or government entity providing them (incentives from the State of Florida, Miami-Dade County, the Beacon Council and cities such as the City of Miami/DDA). Mr. Perez also compared major US metros with the personal and corporate income tax structure and sales tax we benefit from in Miami-Dade County.

Due to time management, the Board members agreed to continue with the incentive discussion at the March 2, 2022 meeting and to invite Mr. James Kohnstamm of the Beacon Council to attend.

5. Business Tax License Report

Ms. Francesca Valdes updated Board members on the new and upcoming businesses in Coral Gables. Currently, the retail vacancy rate is 6.8% on Miracle Mile which is down 5.5% from the last quarter, 5% for the Business Improvement District and 2.3% overall for the City.

6. Open Discussion

There being no further discussion, the meeting was adjourned at 9:30 a.m.
