**RESOLUTION NO. 2023-287**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING MAKE-A-WISH SOUTHERN FLORIDA TO SELL ALCOHOLIC BEVERAGES AT THE PARKING LOT LOCATED ON 1559 SUNSET DRIVE AND ON SAN IGNACIO AVENUE FROM RED ROAD TO YUMURI STREET ON SATURDAY MARCH 9TH, 2024 BEGINNING AT 11:30 A.M. UNTIL 4:00 P.M. DURING THE “*WINGS FOR WISHES*” EVENT, TO BENEFIT THE MAKE-A-WISH SOUTHERN FLORIDA, SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS; AND AUTHORIZING THE WAIVER OF SPECIAL EVENT FEES, PARKING FEES, AND BARRICADE FEES FOR THE EVENT.

**WHEREAS**, the Make-a-Wish Foundation’s mission is to create life-changing wishes for children with critical illnesses; and

**WHEREAS**, the “*Wings for Wishes*” event is one of the Make-a-Wish Foundation’s key fundraising events, the proceeds of which benefit children; and

**WHEREAS**, the City Commission desires to waive the special event permit fees, parking fees, and barricade fees for the “*Wings for Wishes*” event being held in the city on March 9th, 2024 in order to provide the greatest benefit to the Make-a-Wish Foundation and encourage similar fundraising events in the City of Coral Gables; and

**WHEREAS**, the City Commission also authorizes Make-A-Wish Southern Florida to sell alcoholic beverages during the event, subject to any Department of Professional Regulation requirements;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby grant permission to Make-a-Wish Southern Florida, to serve alcoholic beverages during the “*Wings for Wishes*” event, subject to adherence to the laws of the State of Florida.


**SECTION 3.** The event will take place at the parking lot located on 1559 Sunset Drive and norther adjacent street (San Ignacio) on Saturday, March 9, 2024, beginning at 11:30 a.m. until 4:00 p.m.; **“Wings for Wishes”** is a fun event hosted by the Make-a-Wish Southern Florida, local professionals committed to making life better for kids with critical illnesses. This request has been approved by the City’s Special Events Committee.

**SECTION 4.** That the City Commission does hereby waive the City’s special event fees, parking fees, and barricade fees for the **“Wings for Wishes”** event on March 9, 2024.

**SECTION 5.** That this Resolution shall become effective upon the date of its passage and adoption herein.




